As you are well aware, the contents of your article are not true and do not constitute an opinion. It appears that the sole purpose is to misrepresent my offices and the people employed therein. The article harms the goodwill and reputation of Gosai Law and its employees, bringing with it pecuniary loss to the company and their employees.

Having regard to the seriousness of the allegations made and the wide accessibility of the article, Gosai Law and its employees are clearly entitled to monetary compensation as well as an apology.

This letter constitutes a demand that you submit to me within 48 hours, --in draft form--a clear and unqualified apology and retraction for your publication, to appear in an equally conspicuous position as that of the article within the next week.
