Dear Kristine Haines-Chiarello,

Your email to Me is *harassment and contempt*.

Your Duty and Obligation as Trustee of the Public Trust, is to Act in accordance with the Rule of Law, the Trustee Act of Ontario, and all other codes, statutes and Acts, including Canada's Criminal Code, to assist Me in fulfilling My Trust obligate Sean's according to Canadian Law.

This is not abusive conduct, this is the first due process of Law in any Common Law Jurisdiction. Suggesting You are above the law is what's known as legal 'gaslighting' and is recognized as a form of emotional and psychological abuse. You've been Wilfully trespassing upon My Trust for over six years now, and I presumed it was exclusively because Your entire office is ignorant and incompetent. But ignorance is no excuse for the Law, and there comes a point when gross incompetence becomes indistinguishable from malice.

I'm telling You that the continuous trespasses upon My Trust Instrument and My Spiritual Convictions Will no longer be tolerated for the sake of My own mental health and well being. I cannot in Good faith continue to communicate with an agency so arrogant that they believe Canada's Criminal Code does not apply to You, or that somehow the Ontario Works Act provides You with immunity from prosecution for continually sending Me threats of economic harm for failing to comply and or agree to some new Act of exploit a Sean while You are engaged in criminal trespass on My Trust obligations.

Criminal breach of trust

336 Every one who, being a trustee of anything for the use or benefit, whether in whole or in part, of another person, or for a public or charitable purpose, converts, with intent to defraud and in contravention of his trust, that thing or any part of it to a use that is not authorized by the trust is guilty of an indictable offence and liable to imprisonment for a term not exceeding fourteen years.

R.S., c. C-34, s. 296
