Good evening, Dawn,

Unfortunately, Dawn, the UNDERTAKING is not addressed to Me, it is addressed to some artificial person, 'Sean VON DEHN' and I clearly advised You that I am not that person. I have also since asked You why You would be using capitis diminutio medius to style a name on an information of any kind because it is a means of legal deception, depriving the Living Man of his inherent, God Given rights by 'tricking' him into accepting liability for an artificial person Created by the Crown.

I believe the Sean VON DEHN You are looking for is in custody of the Ministry of Birth, Marriage and Death Certificates.

Is there any reason that the Trustee Act of Ontario would not apply to You? You have been Given Notice of My Trust Instrument on file with Canada's MOJAG, are You ignorant of the Law and believe that is an acceptable excuse, or are You Willfully breaching on My Trust obligations with malicious intent?
