Good late morning,

If I do not receive a reply to this email by the end of the day to tell Me when I can expect a response that addresses every point in My email, I Will presume You are conspiring with the City of Ottawa to trespass upon My Trust obligations and to interfere with My right to freely dispose of My natural wealth without prejudice to foreign obligations in violation of international Law and the Covenant on Civil and Political Rights ratified by Canada in March of 1976.

In particular, I would like a copy of the receipt I Signed for MHI to take rent from the public Trust account Created for 'Sean von Dehn's Benefit.
