Thank you for your email. Our office mails out annual review packages yearly as part of our process. This year the process started in March. On March 26<sup>th</sup>, 2024 we sent out the renewal and on April 23, 2024 a reminder was issued. As both events did not generate a package completion or correspondence, we sent you a package via registered mail on May 23, 2024.

Canada post was unsuccessful in delivering the package and once returned us on June 14, 2024 which our mail room had to sign for the package.

- What is your current address?
- Are you still in receipt of Ontario Works?
- If yes, may I contact your worker for confirmation of benefit?

You have not EVER sent out renewal packages, I have not 'officially' had any contract with You since I moved to 320 Via Chiani Grove. I met with Lori Simpson on September 11th of last year because subsidy was cut off without notice to Me *three times so far!!!*

***I met with Lori Simpson on September 11th of last year at 370 Catherine Street and Signed a form to let MHI take rent directly from the public Trust account created for Sean von Dehn's benefit.***

No One else was involved in that contract, and it does not require renewing once a year. No One from this office would even contact Me after You'd cut off the subsidy because YOU KNOW You are criminally negligent.

So no. You've proven to be entirely irresponsible and untrustworthy, You only ever cause Me harm, I Will Sign contracts exclusively with the landlord, and You Will officially stop trespassing upon My right to freely dispose of My natural wealth in violation of Your legal and lawful obligations under international law and My Trust Instrument on file.

The Home for Good subsidy is a provincial program administered by the City in its role as Service Manager. Attached are the guidelines for the program. Please refer to p.13/40 of the guidelines where it is noted that Service Managers are encouraged to deliver the subsidies in accordance with the portable housing benefit set out in the regulations under the Housing Services Act, 2011.

For ease of reference, the portable housing benefit framework is found in Schedule 4.1 of O. Regulation 367/11 [O. Reg. 367/11: GENERAL \(ontario.ca\)](#) and requires, under Section 5 of that schedule, that the continued eligibility and the amount of the benefit payable be reviewed every 12 months.

If you cannot confirm the required information, your continued eligibility cannot be determined.

Attached for your viewing is our records of the registered mail.

Dear Kelly,

Your attempt to gaslight Me is not appreciated, nor is Your 'tone'. I have advised You VERY CLEARLY that because You have been **criminally negligent** in providing subsidy and using the requirements to cause harm to People rather than ensure their subsidy remains intact, You **have not** had any contract with Me since **at least** September 11th of 2023 when I arranged to ensure that over \$10k of unpaid rent was paid to the landlord directly from the public Trust account Created for Sean von Dehn's benefit (Social Insurance Account). I also provided consent forms to contact any Ministry within the Canadian government necessary to confirm income eligibility. I do not provide those consent forms so that You can abuse them or ignore them. That's the whole point to providing You with consent so that if You believe You don't have the required information or believe the tenant no longer qualifies for the subsidy, You can contact the appropriate Ministries to confirm - You don't just cut some One off without notice - that is illegal, unlawful, contemptuous, and not responding to My emails and continuing to assert Your position without addressing My arguments is gaslighting and a form of psychological and emotional abuse recognized by the Courts.

Why does the Trustee Act of Ontario not apply to You? Why are You trespassing upon My right to freely dispose of My natural wealth without prejudice to foreign obligations in violation of the U.N. Charter on Civil and Political rights?

The Powers, Rights and Immunities of the Trust Instrument are in addition to those inferred by the Trustee Act of Ontario which has effect subject to the terms and conditions of the instrument creating the Trust.

I'm sick and tired of 'State Actors' presuming You are above the law or that You can 'pick and choose' which laws apply to You.

You explain to Me why You are not bound by the Trustee Act of Ontario and the U.N. Covenant on Civil and Political rights - again, I'll wait...

Also, I REQUIRE a copy of the form that I Signed last year to allow MHI to take over \$10,000.00 in backpay for rent because You had revoked the subsidy without any notice to Me for **over a year**.

You have clearly **breached the contract I Signed with MHI**, and that contract was exclusively to avoid having to deal with agents at Home for Good who appear to have no respect for My Trust obligations, Spiritual convictions, or My inherent rights according to the Trustee Act of Ontario and the U.N.C.C.P.R.

That contract was Signed on September 11th last year. That's when the subsidy was restored, and not by You - by ME!!!

I am contracting with the landlord directly under duress because I'm 'triggered' by Your agents who have no respect for the inherent rights of the People they were Trusted to serve, and use the subsidy provided as a tool to threaten and intimidate People into compliance in violation of their inherent rights.

Until You show Me when You sent Notice to Me advising Me that the subsidy was revoked in June, You are criminally negligent for the N4 I was served with. I had a contract with MHI and You appear to be interfering with that contract with malicious intent to cause harm. And You don't like the tone of My letters?! You have some nerve!!! I am NOT criminally negligent, You are Your agents are!!!

You cut off rent for over a year without even telling Me, none of Your agents would communicate with Me to explain why, and I fixed the problem, NOT YOU!!! You didn't arrange to meet My landlord to get them paid, I did!!!

So never again Will I Trust You or any of Your agents to provide a service to Me after the criminal negligence and incompetence I have experienced, I can't handle that level of abuse anymore.
