Sally A. Gomery, You are on Notice of Criminal and Civil Liability in Your personal, private capacity for violating the Rules of Civil Procedure 1.09 in Claim 21-86803, where You decided to collude and conspire with the City of Ottawa to dismiss a Claim without any requisition for such Action being made to the Court.

At the time the decision was made, opposing counsel had already been Noted in Default by the Registrar 'Mike'. Mike is an Honourable representative of the Superior Court of Justice and assured Me that once opposing counsel is Noted in Default, the Default Judgment cannot be overturned without a Motion to the Court and Notice to Me.

However, Genevieve Langlais was not very happy to find that she had been Noted in default for privately petitioning Sally A. Gomery in violation of the Rules and Sally A. Of course, because the City of Ottawa has completely compromised the clerks at the Ottawa Superior Court of Justice, Steven Pardou was only too happy to collude with the City of Ottawa's liar posing as a lawyer to help the City deprive Me of My right to Canada's Justice system, and removed the Default Judgment from the Court of Record so that the unlawful endorsement obtained in fraud dismissing the Claim could be added in its place!

This is an official request for the MASTER COURT OF RECORD showing when documents were electronically received and accepted by the Court and added to the Registry. This MASTER RECORD Will Show all changes that were made to the Registry from the commencement of the Claim. This MASTER RECORD is required for the purpose of litigation against these conspiring criminals to irrefutably prove the fraud on its face. Affidavit testimony by the City of Ottawa cannot be Trusted as Genevieve has been known to engage in fraud and perjury on the Court of Record, violate the Rules of Procedure with malicious intent to deprive opposing counsel of their right to a free and impartial trial, and should be charged with TREASON for using her profession to conspire against Canada's People and collude with her criminal clients.

And then of course there is 22-89835 where Derrick Bert has tried to convince Me that fraud isn't fraud and it's perfectly acceptable for the Bracebridge Courthouse to Issue Certificates of Appointment of Estate Trustee without posting the Certificate and Appointment to the Court of Record so that other Courts in the province know who is responsible for receiving claims against the Estate.

Two Judges have ruled that My brother and sister are not engaged in fraud while Michael von Dehn is receiving claims 'in care of' Joachim von Dehn in the Toronto Courthouse, Tanja Johnson is claiming to have been 'duly appointed' by the Bracebridge Courthouse and the Ottawa Courthouse who said they couldn't make arrests when I first reported this to them because they don't deal with 'criminal matters' only Civil Matters and if My siblings are engaged in fraud, I Will need to bring a claim against them.
