Good morning, Nathalie Gougeon and Wendy Stephanson,

I reported to You previously that City of Ottawa employees are engaged in fraud, obstructing My access to Justice and Canada's Courts, primarily the Ottawa Superior Court of Justice and the Ottawa Provincial Court of Justice, and that I have reported these crimes to My local police but they are conspiring with these criminals and now making 'house calls' to threaten and intimidate Me rather than arresting the criminals obstructing My access to Justice and using the Courts as a cloak for insurance and estate fraud. They are even conspiring with City of Ottawa employees to 'impersonate' the Crown Attorney's office to bring false charges against Me in mock Courts 'off the public Record' (not processed onto the Registry).

The City of Ottawa's Kimberly MacDonald has been sending Me fraudulent police informations from an email they created *specifically to perpetrate their fraud*, 'Virtual.CrownOttawa@Ontario.ca' that have not been processed onto the Ministry of the Attorney General and Department of Justice *Registry*, effectively *impersonating* Crown to Give the illusion of due process for the express purpose of weaponizing the police against Me, presumably for reporting these crimes (of which the Ottawa Police Service is complicit).

These are all City of Ottawa employees in one capacity or another, using the Provincial and Superior Courts as a cloak for fraud to harass and intimidate Me. You are telling Me that no One in receipt of this email, including the entire Ottawa Police Service can apprehend the criminals obstructing My access to Justice? No One can even guarantee these emails Will be forwarded to a competent, judicial authority?

You don't feel, Nathalie, that at the very least if You are unable to take any action Your Self, that this issue isn't important enough for You to immediately forward My emails to You to the appropriate Ministry to put these crimes to a stop? You can't help Me receive protection from criminals conspiring against Me in Your own city?

And You expect to tell a Judge that You are not criminally negligent for allowing the harm to continue? And what about You, Wendy Stephanson? Same question.

Wendy Stephanson doesn't have enough resources at her disposal to put these crimes to a stop? Or she does, but does not Wish to? Criminal negligence causing harm, breach of Trust... Do any of You have an ounce of competence?

You have already allowed for a fraudulent hearing to take place at 100 Constellation Drive, impersonating the Ontario Court of Justice, processing a 'parking ticket' in the amount of \$6280.00 which You appear to have cashed?! Kimberly MacDonald provided the 'Certified True Copy' in reply to My request for the Court of Record regarding that fine. It is attached for Your convenience (also see the latest - more city of Ottawa fraud).

You've got City of Ottawa staff setting up fake email addresses so they can trick Me into believing I am being tried in a legitimate Court run by City of Ottawa employees at 100 Constellation Drive that the Ministry of the Attorney General and Department of Justice know nothing about, and You can't do anything about that?! It is not Your responsibility

to put this kind of fraud to a stop as the 'fraud and waste' management auditor for the City of Ottawa? What exactly are We paying You for, Nathalie the Goulish Gougeon?

Because You are so incompetent, I have taken the liberty of including the emails to One of the other institutions You recommend I try. Let's see how many institutions We have to contact to get criminal clerks and corrupt prosecutors out of the Ottawa Courthouses.
