Factual Summary

To the Prosecutor for the International Criminal Court of Justice,

I submit this application on behalf of Canada's People, alleging crimes against humanity under Article 7 of the Rome Statute. The allegations center on Canadian State Actorsâ€TM systematic suppression of evidence regarding mRNA COVID-19 vaccine harms, enabling unconstitutional, coercive mandates in violation of Nuremberg Principles governing informed consent that caused widespread harm, and their subsequent failure to respond to public notices expressing concerns regarding emerging data showing the unlawfully mandated medical products were not 'safe and effective' as they had incorrectly advised Canada's People, constituting a serious breach of public trust under Canadian law. The named individuals include Vera Etches (Ottawa Public Health), Nathalie Gougeon (Auditor General, City of Ottawa), Wendy Stephanson (City Manager, Ottawa), Habib Sayah (Executive Director, Ottawa Police Service), Cathy Curry (Ottawa City Councillor), Peter Sloly (former Ottawa Police Chief), and Sandra Antonini (Ontario Provincial Court Justice), alongside systemic actors in the House of Commons, Health Canada, and transnational entities (Pfizer, NIH, WIV).

1. Factual Basis

- Widespread Harm from Coercive Mandates:
- Cleveland Clinic Study (medRxiv, 2022,): Demonstrates bivalent vaccine effectiveness at 4% (XBB strain), with *higher infection risk per prior monovalent dose* (hazard ratio *increased*, see attached graphic from the study). Unvaccinated individuals were 6–13 times less likely to contract COVID-19, questioning mandate necessity. Mandates in Ottawa and Canada coerced vaccination, threatening job loss, economic harms, and exclusion from essential public services (one was not entitled to social benefits if terminated for 'refusing' to receive the jab, for example), despite minimal benefit, causing many serious and lethal adverse events.
- Pfizer Data: 28/270 pregnancy losses (10.37%, likely 13–20 weeks), exceeding baseline (~2–5%, BJOG, 2023).
 VAERS reported 2,346 pregnancy-related events, CAEFISS 47 events, and Pfizer hid 17 cardiac deaths in trials. PHAC admitted 11,000 serious adverse events, including 88 spontaneous abortions, yet mandates persisted while State Actors actively coordinated to cover up the data and demonize individuals attempting to alert Canadains to the potential risks.
- Sean Hartman Case: A 17-year-old Canadian allegedly died due to vaccine-related causes, highlighting individual harm from mandates. Judge Antonini dismissed the Claim, stating that Canada has no 'duty of care' to ensure the products they are mandating upon their citizenry are 'safe and effective' as promised, and that '倜*A possible side effect of receiving a Covid-19 vaccine was death"* no One in Canada was ever advised the medical product they were being instructed to take would potentially result in death to some individuals, much less children. This constitues a serious breach of public Trust,

crimes against humanity, and implies systemic corrupt as Jugdes and police (the People Trusted to protect the constitutional rights of Canada's People) were threatened with termination for failing to comply with the unlawful, unconstitutional mandates in violation of Canada's Charter rights (section 7) and the Nuremberg Principles governing informed consent. If those Trusted to protect the Constitutional and Charter rights of Canada's People are violating their own Charter rights in order to avoid being terminated, what likelihood is it that those same individuals are going to defend the constitutional rights of their fellow Canadian? Judges were not allowed to receive any more cases if they failed to comply with the unlawful mandate.

- Systematic Suppression of Evidence:
- Helen Grus Investigation: Detective Grus, Ottawa Police Service (OPS), investigated a spike in sudden infant deaths (SIDS, 6–9 cases, 2021–2022) linked to maternal vaccination, citing Pfizer's data (fetal harms, excluded pregnant women from trials). OPS leadership (Sloly, Sayah) suspended her (February 4, 2022), banned COVID-19 discussions in SACA, and faced PHAC lobbying to charge her for Honouring her oath and investigating the infant deaths. The tribunal (2022–2025) rejected vaccine harm testimony, and CBC leaks vilified her, suggesting intent to suppress harm inquiries.
- Lab Leak Cover-Up: U.S. officials used burner phones and deleted emails to evade FOIA requests (The New York Times, May 27, 2024), hiding lab leak plausibility. This mirrors Grusâ€TMs silencing, showing a pattern of narrative control (web:15).
- CDC Misclassification: Unmatched cases assumed unvaccinated, inflating unvaccinated deaths (94,640, MMWR, 2022) to justify mandates, aligning with outdated data concerns and manipulation of information.
- State Actorsâ€[™] Knowledge and Inaction:
- Public Notices: The complainant served three notices (two prior for "criminal negligence causing genocide,†corrected to "crimes against humanityâ€) on Etches, Gougeon, Stephanson, Sayah, Curry, Sloly, Antonini, and the House of Commons, including the Cleveland Clinic study (medRxiv, 2022) and questions about Grus's shutdown. Email service is lawful in Canada since the pandemic, yet no response has been received in over a week, despite a legal duty to respond in a "reasonable time†(Canadian administrative law, Charter principles).
- Grusâ€TMs Evidence: Grus submitted Pfizer data to OPSâ€TMs Professional Standards Unit (May 2022) and met Sloly (January 2022), establishing early knowledge of harms. OPSâ€TMs refusal to investigate or disclose findings enabled harmful mandates.
- Breach of Public Trust: State Actorsâ€[™] silence constitutes a criminal act under Canadian law (breach of public trust), as they are obligated to respond to serious notices from citizens, especially on public safety. This inaction, post-notice, implies knowledge and complicity in ongoing harms.
- Retaliation and Court Misconduct:
- Economic Harm: Ottawa officials cut medical benefits this month, use the Ottawa Police Service to intimidate in retaliating for notices (police officers stalking My apartment and 'warning' Me not to send any more Notices to Executive Director, Habib A. Sayah, and trespassed on a Trust Instrument filed with the Ministry of the Attorney General (MOJAG), a pattern ongoing for years.
- Judicial Misconduct: Courts failed to process the complainantâ€TMs claims onto the Registry, arranging private meetings with clerks and judicial authorities, using the courts as a cloak for fraud to intimidate by proceeding against Me 'privately', 'off the Record', violating the Rule of Law, Rule 1.09 of Ontarioâ€TMs Rules of Civil Procedure and Charter Principles (right to be informed, right to a fair and public hearing). Antoniniâ€TMs ruling of "no duty of care†shields State Actors, aligning with JCCFâ€TMs 2023 judicial bias claims.

2. Legal Violations

- Crimes Against Humanity (Article 7):
- Inhumane Acts: Coerced mandates, despite minimal efficacy (medRxiv, 4%) and known harms, caused serious harm (adverse events, deaths). Even as this data is emerging, State Actors and mainstream media continued to tell Canada's People the jabs were 'safe and effective', though there is zero data to support this claim. Suppression of Grusâ€TMs investigation, lab leak evidence (NY Times), and Pfizer's clinical trial data enabled this, constituting a serious breach of public Trust and a systematic attack on civilians.
- Knowledge: Notices, Grusâ€TMs submissions, and public data establish State Actorsâ€TM knowledge of harms, yet they persisted with mandates and silenced dissent. They continue to push these medical products (mRNA 'vaccines') despite new data showing they are more likely to cause an infection that prevent one. Every jab also increased the likeliness of an adverse event, some of which are lethal for some (myocarditis, blood clots, paralysis, sudden death). (Cleveland Clinic Study, 2022).

- Widespread/Systematic: Mandates affected millions, with suppression coordinated across OPS, the judiciary (rulings by Antonini and Perkins McVey), and global state actors.
- Charter Violations:
- Section 7 (Security of Person): Coerced experimental vaccines violated bodily autonomy, causing serious harm (medRxiv,).
- Section 2(b) (Free Expression): Discrediting Grus and the weaponization of police and courts against Me for attempting to report My concerns, alongside court misconduct, and a complicit judiciary suppressed dissent.
- Nuremberg Principle I: Coerced medical interventions, ignoring natural immunity, violated informed consent.
- Breach of Public Trust (Canada): State Actorsâ€TM failure to respond to notices expressing concerns of harms done by these medical products and shutting down Grus investigation into a 'spike' in fetal deaths violates their duty of care to citizens, a criminal act under Canadian law, (breach of public Trust) compounding complicity in harms.

3. Jurisdiction and Complementarity

• Jurisdiction: Canada is a Rome Statute signatory, subjecting Etches, Gougeon, Stephanson, Sayah, Curry, Sloly, Antonini, and Health Canada officials to ICC jurisdiction. Transnational actors (Pfizer, NIH, WIV) justify ICC scope.

Complementarity: Domestic courts are unwilling, as evidenced by Antoniniâ€[™]s ruling, JCCFâ€[™]s 2023 judicial bias claims, and court misconduct (private 'off the Record' hearings, police intimidation, numerous Rule 1.09 violations).

4. Requests

- Subpoena:
- Pfizerâ€TMs gestational data, CAEFISS (Canadian Adverse Events Following Immunization Surveillance System) records, medRxivâ€TMs zero-shot data, CDC autopsies, NIH burner phone/email logs, WIV logs, OPSâ€TMs COVID-19 discussion ban records, PHACâ€TMs (Public Health Authorities Canada) lobbying correspondence, and House of Commons mandate vote records.
- Investigate Etches, Gougeon, Stephanson, Sayah, Curry, Sloly, Antonini, Health Minister, Fauci, and Pfizer executives for knowledge/intent.
- Audit Canada's mandate policies, OPS's Grus response, Health Canada's Pfizer data handling, and Ottawa's retaliation (medical benefits cut).
- Examine court misconduct (MOJAG, Antonini) and firing of Judicial authorities who refused the jab for systemic bias.

5. Conclusion

The evidenceâ€"Cleveland Clinic's minimal efficacy (medRxiv), Pfizer's suppressed harms, Grus's shutdown, lab leak cover-up, and State Actors' silence post-notice â€" demonstrates a systematic attack on civilians through coercive mandates and suppressed truth. Their breach of public trust and retaliation against Me further implicate them. The fact that no State Actor has EVER replied to a request for data to show the jabs are as 'safe and effective' as Promised is seriously concerning. Ottawa Public Health was going to door to door in My community, pushing vaccines and promising People they were 'safe and effective' but had no medical records or clinical data to prove their claims. Recent studies suggest the products were a complete failure that most certainly caused harm, and the refusal of State Actors to pull these products or even respond to emails of criticism and inquiry is suspect at best. If there was no 'ill intent' and the vaccines were to improve the lives of Canadians, then why the reluctance to share this data and alert Canadians to the potential risks NOW if they were previously ignorant.

I urge the ICC to investigate these crimes against humanity, holding accountable those who prioritized narrative over human lives.
