Dear Mr. Hart Shouldice,

I am looking for some One from the Crown Attorney's Office that I can Trust to report Registry fraud. The Ottawa Police are conspiring with corrupt prosecutors to proceed against Me in fraud by not processing documents onto the Court Registry, or by creating a *fake* name so that it doesn't relate to any 'real' person on the Registry. They send information by Way of email from a fraudulent email address (virtual.crownottawa@ontario.ca, rather than the correct email 'virtualcrownottawa@ontario.ca'. The prosecutors are legitimate Crown prosecutors, knowingly engaged in Registry fraud, also using 'fake' email addresses for contact, and I have been instructed by the Ministry of the Attorney General to block the email address 'virtual.crownottawa@ontario.ca', but it does not stop them from sending Me notices of new court dates (that there is absolutely no public Record of) by Way of regular mail. Yvonne Goebel authored one of these fraudulent letters sent by Way of regular mail.

I have reported these crimes to every provincial Court in the province, yet they are engaged in the same fraud again, this time conspiring with not for profit landlord, Multifaith Housing Initiative. I have no criminal record, have never been in trouble with the Law (outside of being arbitrarily assaulted by corrupt police officers in the City of Ottawa for My advocacy work as a freelance journalist).

I am Writing You, Mr. Shouldice, because I Trust You - You have helped Me before. The first time the Ottawa Police proceeded against Me in fraud, they changed My Court date and had a warrant issued for My arrest, despite the fact I had only learned about it by showing up on the date I was told to be there. I walked into Courtroom number six and asked if it was the correct Courtroom to remove a bench warrant for failing to appear when I am standing in a Courtroom demanding to speak with a judge to address the charges.

You immediately stood up and said that the court was adjourned for lunch, but Promised You Will take care of it for Me and asked Me to wait for You in the lounge outside the Courtroom. Roughly five minutes later You kept Your Word, asked Me what date I Wished to reschedule My hearing and I told You I didn't care so long as the bench warrant was removed immediately. You were also in the Courtroom for My next scheduled hearing and You heard whatever testimony I made to the Court that day - the charges were withdrawn at request of Crown the following day. I can't help but wonder if You had something to do with that, too. I only know Your name because it was Writ in all capital letters on the side of one of Your books texts 'SHOULDICE'.

I'm also on 'X', following You now - [I hope You Will consider following Me back](#). There are a lot of lawyers conspiring against Me, so I don't generally have much Good to say about the profession, though I try not to discriminate against all lawyers, knowing some are Good and took up the profession with an earnest desire to protect the Rule of Law and Principles integral to Justice. All I can do is hope You are One of them.

I do have tremendous respect for the fact that You are a stand up comedian by night, regardless Your opinion of this email! It is on My personal 'bucket list' one day. Standing up in front of People can be tough for some in its own right - but to be expected to make People laugh? That's a lot of pressure and it takes a lot of confidence and talent. I hope I have a chance to see Your show sometime.

I have all the evidence You could ever possibly need. For the new fraudulent charges, I Will be hiring a lawyer who is not afraid to take on government and other corrupt State Actors. To the best of My knowledge, I'm the first Man to bring a claim against Canada for mandating medical products in violation of the Nuremberg Principles governing informed consent, constituting crimes against humanity before the International Criminal Court of Justice at The Hague. I can't help but wonder if that has something to do with the discrimination and extreme prejudice I am being subject to by these criminals impersonating Crown.

This email Will be added to the International Court of Record regarding this Matter at www.vondehnvisuals.com. I need to find some One who works for Crown that can help Me eliminate criminal 'moles' using the Courts as a cloak for fraud and exploitation of Canada's People.

386 Every person is guilty of an indictable offence and liable to imprisonment for a term of not more than five years or is guilty of an offence punishable on summary conviction who, as principal, agent or mandatary in a proceeding to register title to real property or immovable property, or in a transaction relating to real property or immovable property that is or is proposed to be registered, knowingly and with intent to deceive,

(a) makes a material false statement or representation,

(b) *suppresses or conceals from a judge or registrar, or any person employed by or assisting the registrar, any material document, fact, matter or information, or*

(c) *is privy to anything mentioned in paragraph (a) or (b).*

NOTICE OF CIVIL AND CRIMINAL LIABILITY AND NOTICE OF CLAIM

Good morning, Mr. Shouldice,

So I hope You can understand why I didn't Give You much time - I thought this would be very important to You and that (at the very least) You would confirm receipt and provide

assurances that You are investigating My complaint with vigilance.

If I do not receive Word from You that You have contacted the appropriate authorities and are investigating the depth and scope of the Kreling Criminal Cabal's fraud cheating Canada's People out of due process, I Will have no choice but to presume You are complicit and the 'Kingpin' of the Kreling Criminal Cabal's Ottawa cell.
