Do You remember this?

You are guilty of cutting off medical benefits in violation of the medical form You have on Record which clearly states that medical transportation allowance and all the other medical benefits were approved by a DOCTOR (and in violation of My Trust Instrument and under duress for threat of further economic harm and exploitation) INDEFINITELY so that I would NOT have to have the conditions approved EVER AGAIN.

I am officially requesting a copy of the medical benefits form You have on file for Me and advising You to get the FULL medical transportation allowance that was unlawfully revoked by Nazi Nana Asante months ago AND the medical benefits I am entitled to INDEFINITELY.

You are causing Me serious harm by Way of Your economic exploitation and REFUSAL to provide copies of documents You have on file for Me showing I am entitled to the benefits You have unlawfully revoked with malicious intent to deprive Me of the resources necessary to maintain My health - and I believe this is retaliation for placing You on Notice for spoliating countless documents from My case file in violation of federal and international Law.

You Will all be charged criminally and in Your personal, private capacity if all benefits are not restored with back pay by the end of today.

You are hereby served with Brian Killick for the Social Benefits Tribunal as My impartial witness. I Will be making an URGENT application to the SBT and filing a report with the RCMP if benefits are not restored on or before 5:00 PM today.

Please also be advised that You have been reported to the International Criminal Court of Justice for crimes against humanity for mandating medical products in violation of the Nuremberg Principles which does not allow You to compel Me to receive medical treatment or counsel under threat of economic exploitation.

Good afternoon, everyOne.

I requested a copy of the Medical Benefits form You have on Record for the Beneficiary of the public Trust, Sean Stephen von Dehn, of which You were appointed to Act as Trustees for his Benefit under **the Trustee Act of Ontario** and **the Ontario Works Act**. I requested a copy of this document because You have a Fiduciary obligation to the Beneficiary to maintain honest and accurate Records, and the Medical Benefits form Will Show that the Beneficiary, Sean Stephen von Dehn's Medical Benefits have been approved by a doctor indefinitely. You also have a Trust Instrument and Trust

Declaration for Sean Stephen von Dehn, a Writ of Mandamus to serve as an indemnity bond for Health Care Provisions, and a Letter of Attorney Showing that King Sean, House von Dehn, is the Trustee and Executor for the Beneficiary Sean von Dehn's Estate, which includes the Supreme Claim of right upon his Father's Estate, Joachim Heinrich von Dehn, and in accordance with the Trust Instrument on file with Canada's MOJAG.

Not only is trespass upon a Trust Instrument a serious breach of Trust, but to threaten a Beneficiary with economic harm in violation of his Trust constitutes a criminal Act, sufficient to request for a Court to Order for the Trustee to be removed and criminal charges laid because the violation involves fraud and theft (failing to provide documents Trusted to Your care upon request for the purpose of litigation (to prove the breach of Trust and unlawful medical benefit revocation) is fraud by Way of omission and or a breach in the duty of care to maintain honest and accurate Records.

Once again, You were Given until 5:00 PM **yesterday to remedy Your breach of Trust**. You were advised that unlawfully revoking medical benefits in violation of the Beneficiary's Trust is causing the Beneficiary serious harm and malnutrition. It is unacceptable that none of the Trustees of Ontario Works appear to be responsibly managing the public Trust and fail to respond to such an urgent notice in reasonable time.

The Beneficiary, Sean Stephen von Dehn's transportation allowance and medical benefits were unlawfully revoked on March 1st of 2025, and the Beneficiary has only been receiving half the transportation allowance he is entitled to since February, 2024.

You were advised in a previous hearing before the SBT that Your revocation of Benefits were entirely unreasonable and unlawful, and You are repeating the offence a second time, and Your failure to respond to this email asserts that You are doing so with malicious intent, or 'mens rae' (of guilty Mind) and should be criminally charged.

Please note that this is 'Final Notice', You may avoid being Noted in Default for malicious breach of Trust with intent to cause economic, physical, psychological and emotional harm to the beneficiary by depriving him of access to basic subsistence necessary for living. These constitute serious crimes and breach of the public Trust by 'State Actors'.

This final Notice Will be followed up with a complaint to the RCMP and the SBT for criminal breaches of the public Trust, and an urgent request to have the Trustee removed to avoid further harm to all Beneficiary's of Ontario Works in the City of Ottawa.

Post Script: Please find below the legislated Acts to support the charges against You.

### Example of a Violation:

- If a trustee is using the recipient's financial assistance for their own personal benefit, such as ***paying for their own expenses*** before those of a beneficiary, ***they would be in violation of their fiduciary duties***.
- *If a trustee fails to manage the funds responsibly, such as by failing to pay rent or utilities (medical needs and provisions), they would also be in violation of their duties, potentially leading to eviction or other consequences for the recipient.*

### Legal Action:

***If a trustee violates their duties under the Trustee Act or the Ontario Works Act, the recipient or the administrator can take legal action to address the violation. This could***

include a **court order to remove the trustee**, an **order for the trustee to repay misused funds**, or even **criminal charges if the violation involves fraud or theft**.

## Trustee Violations and Consequences:

### Breach of Trust:

A trustee in **Ontario Works** has specific **fiduciary duties to the beneficiary**, including **the duty to act diligently and honestly**, to keep **accurate records**, and **to account for the trust assets**. If a trustee fails to fulfill these duties, such as by **misusing the funds** or **failing to manage them responsibly**, they could be in **breach of trust**, leading to potential legal action from the **beneficiary** or the administrator.

### Ontario Works Act, 1997, S.O. 1997, c. 25, Sch. A:

This act provides for the appointment of **trustees** when a recipient's financial assistance is managed by someone else. It outlines the circumstances under which a trustee can be appointed, the responsibilities of the trustee, and the consequences of failing to meet those responsibilities.

### Trustee Act (R.S.O. 1990, c. T.23):

This act outlines the powers and duties of trustees in Ontario. It includes **provisions for appointing new trustees**, **removing trustees who are unfit or incapable**, and **ensuring that trustees act in the best interests of the beneficiary**.
