Dear Registrar for the Social Benefits Tribunal,

The administrator and case presenter, Caroline Forget, believe that the Trustee Act of Ontario does not apply to them and that they may trespass and violate My Trust obligations and Spiritual convictions with IMPUNITY because they also appear to believe that Canada's Criminal Code does not apply to them for failing to provide a lawful excuse for their trespass on the same Trust Instrument.

They routinely and repeatedly plead ignorance of My Trust on file with MOJAG while continually looking for new ways to exploit the beneficiary economically by reducing the benefits he is entitled to and under threat of further breaches of Trust in violation of his Spiritual beliefs and Trust obligations. They perform these Acts with malicious intent to cause harm and continually 'gaslight' when directly asked what legislation provides for agents of Ontario Works with the right to trespass upon the Spiritual convictions and Trust obligations of beneficiaries Trusted to their care.

Caroline Forget has also been asked with the SBT's Brian Killick bearing witness to My emails, requesting copies of contracts Signed by Case Workers of Ontario Works promising to Honour exactly the Trust obligations and Spiritual convictions outlined in this appeal.

I Trust this email constitutes legal and lawful filing of My appeal to the Social Benefits Tribunal. This Matter is urgent as the harm being done to the Beneficiary is ongoing. Caroline Forget REFUSES to answer simple questions, such as 'why is the Trustee Act of Ontario not binding upon Sean Stephen von Dehn, Ontario Works agents, and the Trust received by Your office for Sean von Dehn's Benefit?'.

The administrator also routinely characterizes placing them on Notice for breach of Trust for failing to address questions and requisitions made to them as 'inappropriate conduct'. They believe they can gaslight with impunity by failing to address the subject Matter of the grievance. This is childish, immature behaviour unbecoming of a 'case presenter' or any One Trusted to care for Canada's People.

I would like for all persons engaged in Acts that constitute a criminal act according to Canada's Criminal Code to be charged accordingly and subject to criminal prosecution unless the Social Benefits Tribunal is of the opinion that the Rule of Law does not apply to the public Trustee.
