Adrienne Curran was advised in the pre-hearing conference that the Administrator destroys documents to plead ignorance of the contracts they are breaching. Breach of contract and spoliation of documents by a Trusted government official are very serious crimes. I advised Adrienne that I believe (at the very least) that the Tribunal has a duty and obligation to advise the Adminstrator that the Rule of Law compels the Administrator to produce any documents on the Beneficiary's case file upon request. Adrienne Curran suggested it is perfectly normal for the Administrator to withhold documents and contracts they have Signed fromm the Beneficiary and Will NOT compel the Administrator to produce the contracts they are breaching. Sean advised that withholding those documents is obstruction of justice and a breach of Trust because they are using the documnets to exploit the Beneficiary and evade accountability.

Sean also clearly advised Adrienne in the pre-hearing conference that he is not 'Self Represented'. An artificial legal person does not have the capacity to do anything because it is not a living entity. Sean
