The SBT will only issue a summons if it is satisfied that the witness has information arguably relevant to the issues that are in dispute in the appeal. Nana Asante unlawfully revoked half the medical travel benefits the Beneficiary is entitled to. The Beneficiary is entitled to the cash equivalent of an adult monthly bus pass. Nana Asante advised Me by Way of email that new legislation had been passed requiring case workers to reduce the Benefit to half the monthly equivalent of an adult buss pass if the Beneficiary does not Wish to receive an 'Equipas' instead of the cash.

This is patently unreasonable and incorrect, as the Beneficiary is paying just as much for public transportaiont as he was before, but only being compensated for half his entitled Benefit expense. Reducing medical benefits of any kind does not Benefit the Beneficiary, it causes the Beneficiary have insufficient wealth to sustain his dietary needs to maintain optimal health. Sean's health has been continuously deteriorating because he is being deprived of sufficient wealth necessary to sustain him Self.

Please note that this is also a rights violation of interntational Law under the Covenant on Civil and

deprived of its own means of subsistence.

Nana Asante is also guilty of pleading ignorance of a Trust Instrument on file for the Beneficiary, mocking the Trust Instrument when it was presented to her in a meeting, and Nana Asante desecrated the Trust Instrument causing irrevocable, permanent harm to the Instrument constituting the Trust and has failed to acknowledge her wrongdoing or take any accountability for her criminal malfeasance and breach of Trust and trespass upon the Trust Instrument.

Nana Asane is guilty of desecration of a Trust Instrument, criminal malfeasance causing harm by Way of trespass upon a Trust Instrument on Record with Ontario Works and MOJAG. Nana Asane 'jests' and 'jokes', saying 'she doesn't care what the Minister of Justice and Attorney General' has to say on the Matter.

Nana Asante is so morally bankrupt, that not only did she not apologize for her criminal act causing the Beneficiary serious harm, she retaliated by revoking half of his medical travel allowance in violation of his Trust and the contracts the Administrator has on file for the Beneficiary.

Nana Asante is required to bring with her a copy of the Trust Instrument and Trust Declaration she made copies of in her last meeting with the Beneficiary in Septemeber of 2023.

I have a copy of the audio from the meeting which was recorded to maintain an accurate record of the filing of these documents and receipt of the Trust with Nana Asante
