Dear 'Operational Support Branch' and Crown Attorney for Service on the Crown,

I would like to advise You that I believe the attached response from the 'Operational Support Branch' is inappropriate, unsatisfactory, and constitutes criminal negligence and professional 'gaslighting'. It is very clear that I am reporting very serious breaches of Trust by clerks of the Court and their supervisors.

Jove Ponniah, associate attorney general and court supervisor for the Toronto Superior Court has been accepting insurance claims against the Estate of Joachim Heinrich von Dehn without requiring service of documents on the responding party (My late father) from 2020 - 2024, showing the claim was served 'in care of' Michael Ramsay von Dehn while the Bracebridge Courthouse is claiming My sister was 'duly appointed' as the Estate Trustee for the Estate of Joachim Heinrich von Dehn on December 8th, 2022. To this day, there is no Record of the Appointment and Michael von Dehn has testified in Civil Claim 22-89835 that Tanja Selma Johnson was appointed as the Estate Trustee by the Bracebridge Courthouse, and that he has nothing more than a 'Beneficial' interest in the Estate.

Please review a few of the claims that have been proceeding against My father 'off the Record' and 'in care of' Michael von Dehn.

The fraud is clear and plain as day. I have reported these crimes to David Lametti, the Crown Law Reception Office, the local police, the Ontario Provincial Police, and each of the Courts involved in the fraud. There are three million dollars in claims proceeding against My father 'off the Record' in the Toronto Courthouse, a Civil Claim against the Estate in the Ottawa Courthouse (22-89835), and an Estate Application which was allegedly concluded, appointing Tanja Selma Johnson as the Estate Trustee for Joachim Heinrich von Dehn. Tanja and Michael state their intentions to split the 'remainder funds' with Tiffany Singh, the individual responsible for the \$3 million worth of damages in the insurance claim. Amazingly, although the Superior Courts are to be of 'inherent and concurrent' jurisdiction, each court is pleading ignorance of the proceedings taking place against the same Estate in other courts! They appear to be very Good at colluding together and initiating a multiplicity of suits against My father in violation of the Courts of Justice Act, but all of My complaints go unanswered.

I have requested a motion to settle the order so that I can report these crimes to Trial Coordinator, Sally A. Gomery so that the Case Law database is not corrupted by determinations obtained in fraud. I advised the Court that I cannot accept a decision that was obtained in fraud in Good faith and with clean hands, every court in the province has been 'ghosting' Me ever since.

Finally, although You assert that My attached email does not constitute service on the Crown, You reference the emails I have served upon the Crown Law reception office, which has also been included in this email. If You were not served in accordance with due process in a Common Law jurisdiction, You would not be responding to it and assigning a case file number. Your reply indicates that You DID receive the Notice of Criminal and Civil Liability served upon Crown, and You are attempting to gaslight by suggesting You do not have any moral or ethical obligation to put the crimes to a stop.

Gillian Kreling is the supervisor of the Ottawa Court obstructing My access to justice and refusing to forward My non-acceptance for fraud to trial coordinator Sally A. Gomery, or accept any filings for motions before a judge to settle the Order.

I would like to see the criminals apprehended, You have more than sufficient 'prima facie' irrefutable evidence to prove the crime and make arrests.

There was no reply to any of My inquires on May 3rd, 2023 as falsely stated in Your email to Me. I maintain very accurate email records and I followed up with Carrie Thompson to find out why she is not responding several times after May 3rd. So You are telling lies in Your reply to Me. Please attach the reply from May 3, 2023 if You believe I received an appropriate response to the Notice of Criminal and Civil Liability served upon Carrie Thompson for encouraging her clerks to engage in fraud, failing to 'process' the application onto the Registry so that the Courts can Act concurrently and congruently in the administration of justice.

You also failed to Sign with a name which I feel is extremely unprofessional and done with intent to avoid personal liability and accountability for Your inappropriate reply to such serious criminal Acts being perpetrated by supervisors of Your courts, colluding with criminal liars posing as lawyers.

This Will be published on the public Record, and this is My official reply to Your response to My complaint related to the file number You cited. You obviously received the complaint if You have assigned a file number to it... Claiming You didn't receive something when it is clear and obvious that You did, allowing the criminal conduct to continue in Canada's courts, is gross criminal malfeasance which has seriously aggravated the mental and economic harm done to Me by this fraud and these criminals.

I would like to know why Canada's Criminal Code does not apply to corrupt clerks colluding with criminal liars posing as lawyers, defrauding Canada's People (and Me in

particular) of My rightful inheritance so that Tiffany Singh can succeed in her insurance scam.

I look forward to hearing from You, and preferably with a more appropriate reply. Your email to Me is unprofessional conduct unbecoming of a clerk of the Superior Courts.

I require a name for the purpose of accountability in any future replies.

Please let Me know if You require further evidence of the fraud before You can make arrests.
