Dear HRTO-Registrar,

I would like People who respond to Me to include their first and last name for the purpose of accountability. You are a judicial body, it is unprofessional in My opinion to send anonymous emails and documents.

Having said that, thank You, received. I Will respond before July 25th.

Very briefly, I Will tell You that the Ontario Works administrator is engaged in malicious breach of contract and trespass upon a Trust Instrument on file with their office. They believe the Rule of Law does not apply to them and that they are not subject to Canada's Criminal Code. The Social Benefits Tribunal is not attempting to resolve the Issue or advise the Administrator to cease and desist their criminal negligence and breach of contract, aggravating the harm done to the Beneficiary. These People all have law degrees of some kind and are allowing criminal harm to continue. The Beneficiary has reported the crimes to the local police, the City of Ottawa City Councillors and was told he must complain to the Social Benefits Tribunal who now tells Me they have no moral or ethical obligation to compel the administrator to Honour their contracts and the Trust Instrument on Record, allowing the criminal conduct to continue because it is 'not in their jurisdiction' to report federal crimes, fraud, spoliation of documents, breach of contract, trespass upon a Trust Instrument and appear to enjoy antagonizing the Beneficiary by continuously referring to him as 'Self Represented' when it is clearly expressed and on Record with MOJAG that King Sean, House von

Dehn is the Trustee and Executor for the artificial person commonly known as Sean Stephen von Dehn.

The Social Benefit Tribunal believes they have no moral or ethical obligation to put the ongoing harm done to the beneficiary to a stop, escalating and aggravating the harm for an additional five months while the Ontario Works administrator 'ghosts' the Appellant and REFUSES to produce copies of the contracts they have agreed to Honour from his case file.

Patenly incorrect and unreasonable to suggest that I can't receive protection from criminals regardless which government agency I report the crimes to, including local police. I am not receiving equal protection from criminals, I am being exploited by criminal trustees and continually told that it is 'out of the jurisdiction' for any One to interfere. Ridiculous. But okay, I guess We Will just allow the Beneficiary to continue suffering as a result of the Tribunal's criminal negligence.

I feel like every judicial body is finding an excuse for the public Trustees rather than providing relief to the Beneficiary from criminals posing as public servants. But I guess 'State Actors' are above the law.

Dear 'HRT0 Registrar',

I'm quite sure that I indicated in My initial filing that I believe I am being discriminated against for My Spiritual beliefs and convictions (creed). According to the Trustee Act of Ontario, the Act applies to all Trusts whenever expressed, and all Trustees whenever appointed. Furthermore, the powers, rights and immunities conferred by the Trustee Act of Ontario are in addition to those conferred by the Instrument creating the Trust and have effect *subject* to the terms thereof. I don't believe that You have any more right to trespass upon My Spiritual beliefs and convictions expressed in My Trust Instrument on Record with MOJAG than the Ontario Works Administration does.

The Trust Instrument was filed with Canada's Minister of Justice and Attorney General on January 19th, 2017. So far, every government agency has been pleading ignorance

of the Trust Instrument, compelling the Trustee to violate his express Trust in God and Spiritual convictions under threat of economic hardship and exploitation by public Trustees for the Ontario Works Administration. The Administrator has signed additional contracts to support the fiduciary obligations of the Trustee in accordance with his Expressed Trust which they are now breaching with impunity before the Social Benefits Tribunal, who are also pleading ignorance of the Trust Instrument which immediately takes jurisdiction as the constitution governing the Beneficiary's Life Purpose.

The Trustee believes that the capitalist system is a system of economic exploitation, allowing individuals and corporations to demand 'whatever the market Will bear', rather than whatever the good actually cost to produce. In a *lawful* world where economic exploitation has not been made 'legal' by Way of legislation, it would be unlawful to charge more than a thing is worth. This is one of the ten Commandments from the Bible that allegedly governs Canadian society, 'thou Shall not covet'. To engage in for profit commerce is to engage in sin as far as the Trustee and Executor for the Beneficiary is concerned.

Suggesting the Administrator for Ontario Works is Acting as a Trustee for the *Benefit* of Canada's People while they pay their Self six figure salaries and exploit Canada's People by depriving them of sufficient wealth for their most basic subsistence, is economic exploitation and a breach of public Trust. It is clearly 'incorrect and unreasonable' to suggest there is sufficient wealth in Canada's public Trust to pay outrageous government salaries, but insufficient wealth to provide Canada's People with a dignified, living wage (which is also a Universal right ratified by Canada under the United Nations Covenant on Civil and Political rights which states that all People are entitled to a living wage worthy of human dignity)? That is economic exploitation by definition and a serious violation of the United Nations Covenant of on Civil and Political rights which states that, 'in no case may a People be deprived of their own means of subsistence'.

Indemnity

63 This Act or *an order purporting to be made under it* is a **complete indemnity** to all persons for *any acts done under the Act or order*, as the case may be. R.S.O. 1990, c. T.23, s. 63.

Trustee, etc., may apply for advice in management of trust property

60 (1) A trustee, guardian or personal representative may, ***without the institution of an action***, apply to the Superior Court of Justice for the opinion, advice or direction of the court on any question respecting the management or administration of the trust property or the assets of a ward or a testator or intestate. R.S.O. 1990, c. T.23, s. 60 (1); 2000, c. 26, Sched. A, s. 15 (2).

The Trustee and Executor *should* be able to apply to the Superior Court of Justice for advice or direction, but the Courts are ghosting Me and refuse to return emails related to the Trust. You are also a branch of MOJAG, so You do not have the luxury of pleading ignorance of the Trust Instrument.

It seems as though the Rule of Law does not apply to Me, and I can only presume to know why. However, considering all 'State Actors' in every capacity are pleading ignorance of the Trust and Tribunals routinely suggest they have no legal or lawful obligation to Honour the Trust because it is 'beyond their jurisdiction'. If it is beyond their jurisdiction, then I can only presume trespassing upon the Trust is also outside of their jurisdiction and a federal offence.

I have worked very closely with the Ontario Works Administrator, showing them what the Trustee Act of Ontario has to say about My Express Trust in God and asking them to Sign contracts to show they understand My fiduciary obligations to the Beneficiary. Obviously, Sean Stephen von Dehn is not an 'artificial legal person', he is a natural person in Law and presumes the artificial person was not created for the purpose of economic exploitation, but rather proof of a Beneficial interest in Canada's constitution and promise to Honour the Sovereignty of Canada's People.

This is My official reply to Your email to Me and I do fully comprehend the content of Your preliminary assessment of the Claim. Because I understand that You do not have the jurisdiction to interfere with Courts or Tribunals, I would like to suggest amending My claim against the individual 'State Actors' who believe that the Rule of Law and Trustee Act of Ontario does not apply to King Sean of House von Dehn and or the artificial person created by the Canadian government presumably indicating evidence of a Beneficial interest in Canada's constitution. I do not Trust the Canadian government to do anything more than guarantee My rights as a natural person with inherent rights Given Me by God and protected under federal and international law.

Once again, in no case shall a People be deprived of its own means of subsistence. It is pretty clear and obvious that I am entirely dependent upon the Ontario Works Administrator for the Beneficiary's most basic subsistence in violation of My Express Trust in God.

I Wish to amend My Claim against the individual state actors who believe the Rule of Law does not apply to them, which includes the following individuals from Ontario Works. I Will add an additional ground for discrimination according to the Code for discriminating against an individual in receipt of Benefits.

The individuals trespassing upon a Trust Instrument on Record with their office are as follows:

1. Clara Freier, Manager of Ontario Works
2. Caroline Forget, Case Presenter for Ontario Works
3. Brian Killick, Vice Chair for Social Benefits Tribunal
4. Madeleine Mbuyi, Resolution officer for the Social Benefits Tribunal who is allowing the breach of Trust to continue with impunity, aggravating the harm done to the Beneficiary and escalating the claim for rights violations. Sean believes he's entitled to protection from criminals, and that tribunals and courts have a legal and lawful obligation to report the crimes of State Actors when they become aware of them.
5. Rita Khavich, Case Worker
6. Nana Asante, Case Worker who also desecrated the Trust Instrument she now pleads ignorance of.
7. Tatiana Lindstrom, Case Worker for Ontario Works violating contracts from the Beneficiary's case file with malicious intent to cause economic harm
8. Orsolya Vancsody, Case Worker who initially received the Trust Instrument in lieu of government identification, recognizing that 'identifying' as an 'artificial legal person' is a violation of the Beneficiary's Trust in God. Orsolya Vancsody also Signed a Mandamus for Health Care creating an indemnity bond to cover any financial obligations necessary for health care. Orsolya Vancsody also Signed a letter of Power of Attorney, clearly stating that she understands the language of the Letter and supports King Sean's right to Act as the Trustee for the artificial person created for his Benefit.
9. Adrienne Curran who says she has no moral, ethical, legal or lawful obligation to put the criminal trespasses of the Ontario Works administrator to a stop the second she learns about it, aggravating the harm done to the Beneficiary.

Once again, this is My official reply as I understand You do not have the jurisdiction to investigate the Social Benefits Tribunal. However, I do know that I can bring a claim against individuals, so I Wish to amend the claim against the individuals who are directly violating contracts they have promised to Honour and trespassing upon My Trust Instrument and Spiritual beliefs and convictions with impunity and in violation of Canada's Criminal Code. I would strongly suggest

that they do this with malicious intent to antagonize and demoralize the Trustee, causing emotional and psychological harm in addition to economic exploitation.

Please advise if You Will amend the Claim against the individuals listed in this email, or if You Wish for Me to redraft the Claim from scratch.

I look forward to hearing from You at Your earliest convenience.
