Dear Mayor Mark Sutcliffe,

I am sharing with You evidence of a serious criminal network and scandal which I believe to be a part of the City of Ottawa's 'kickback scheme' which is currently under investigation by the Auditor General, Nathalie Gougeon (who has been included on this email to witness service of this Notice of Civil and Criminal Liability on You for the City of Ottawa as her Mayor).

The Home for Good program set up by the City of Ottawa use consent forms they obtain from tenants which are provided to them in Good faith for the purpose of verifying eligibility for subsidy, to learn how much the tenant is paying in rent, utilities and rental insurance for the subsidy application. When the application is approved, Home for Good Gives all the money they receive for rental insurance and utilities to the landlord while the Beneficiary continues to pay utilities and rental insurance from the basic needs portion of their Ontario Works benefits.

Ontario Works is complicit in the grift, providing the housing expenses to Home for Good staff so they can put it in their application for subsidy, then turn around and Give that money to the not for profit landlord Multifaith Housing Initiative instead. Ontario Works simultaneously lie to the Beneficiary and tell him he is not entitled to utilities and rental insurance as part of the shelter allowance he's Entitled to.

Meanwhile, they receive an 'Entitlement Form' every year from Home for Good showing exactly what the Beneficiary is Entitled to receive, showing those funds are being paid to the landlord while the Beneficiary continues to pay those expenses from the basic needs portion of his Ontario Works benefits.

To make Matters worse, case workers, team leads, their supervisors and even the general manager of Ontario Works, Clara Freier, LIED to the Beneficiary and insisted that utilities and rental insurance are not part of the Housing subsidy he is Entitled to receive while the landlord was simultaneously pocketing the same money and obtaining the information necessary to perpetrate their grift from the Beneficiary's case worker. The same case worker is taking the same utilities from the basic needs portion of Benefits that are being paid to the landlord by the City of Ottawa's Housing Authority.

And just to demonstrate the malicious intent of criminals like Lili Mukalay of Ontario Works, even after the Beneficiary receives a copy of the Entitlement Form clearly showing how much the landlord has been stealing in funds they've received for utilities that the Beneficiary has been paying, Lili Mukalay REDUCES the shelter portion of Benefits the Beneficiary is Entitled to receive from the province so that she does not have to pay the Beneficiary's utilities (and also making the Application for subsidy entirely fraudulent because it says Ontario Works Will pay \$390 from July-Jun 2026 which is to include utilities in the amount of \$60) to \$330. to ensure the Beneficiary doesn't receive the funds for utilities he's entitled to receive so she can double down on her fraud.

She's also pre-emptively advised Me that Ontario Works can reduce the shelter portion of Benefits at their own discretion if they are paying the money to a third party, so the Beneficiary shouldn't even bother appealing the decision to the Social Benefits Tribunal because it doesn't even have the jurisdiction or authority to speak to any money they are paying to third parties like corrupt landlord, MHI. She's literally telling Me that she can pay however much of the shelter portion of Benefits as she wants depending on how she feels and what she Wishes to Give the Beneficiary of that which he is Entitled to receive.

Ontario Works is perfectly fine to approve the applications when the money is going into the pockets of not for profit slumlord Multifaith Housing Initiative, but they are refusing to do with the funds what they are claiming to do in their own applications?

Is the mayor capable of finding some One who can put this criminal cabal to bed for Good? I can tell You from experience, the entire Home for Good staff are corrupt to the core. Will anything be done about it, and how long before I can expect the City to find some One competent enough to respond to emails?

Your associate legal counsel, Genevieve Langlais has had a front seat as this grand scandal has been unfolding. So far she has had 'nothing to say'. How about You, Mr. Mayor? What do You have to say?

Is the Beneficiary receiving an Entitlement Form for the first time as a result of Nathalie Gougeon's investigation into the City of Ottawa's kickback scheme? If so, I must say 'Bravo, Nathalie!' I am impressed - maybe. Depending on what is done about it.
