Good morning, every One,

So Sarah Lorenz tells Me that MHI are not engaged in fraud and that she had no idea the landlord had been claiming to pay the tenant's utilities. Sarah says MHI have only ever received funds for rent and that I need to talk to the People at Home for Good with respect to the extra money the Beneficiary was Entitled to receive to pay his utilities. Apparently, that money is in the hands of Home for Good staff.

Sarah claims that rent increased to \$1078.00 in November of 2023 (though the tenant does not recall ever being served with Notice of that increase before yesterday) through November of 2024, and that the 'actual rent' for the unit in June of 2025 was \$1104.00 (not \$1078.00 as stated in the 2024-2025 Entitlement Notice) after increasing in November of 2024 through November 2025.

This means that the Entitlement Form I received for the Beneficiary for the years of 2024-2025 and 2025-2026 are both entirely incorrect and clearly not an accurate Record of the application for subsidy. Is there any chance I can see copies of the actual forms that were sent to the Housing Authority along with the supporting documents attached (as You're allegedly required to send Me every year)?

Any chance I can get an accurate statement of accounting from any One. Either Sarah is lying to Me about the rent or You are not telling the Truth about rent in Your applications for subsidy. Surely, if You are demonstrating this degree of incompetence in the materials You are 'Trusted' to file for the Beneficiary, My oversight is required to protect the Beneficiary from further theft of public money.

This is why I am to be carbon copied on any applications for subsidy made in the Beneficiary's name because everything I've seen so far appears to be fraudulent or incorrect. Once again, I have a statement before Me know from June 29th, 2023 saying that \$8,6016.00 was outstanding at that time because Home for Good had unlawfully revoked the subsidy - i don't see that reflected in the Entitlement Form for the same period.

Sarah Lorenz served Me with a new Notice of Rent Increase yesterday, effective December of this year, which Will (finally) make the 'actual rent' cost made in the

Entitlement Notice this year a true statement of facts, but she hasn't said what's being done with the extra \$60.00 You are requesting for utilities and not using to pay utilities.

Jason Cooke tells Me that the Entitlement Forms he provided to Me on Friday are a True and correct statement of facts, Sarah Lorenz swears she served Me these Notice of rent increase but both of You can't be telling the Truth, can You? So who is lying?

Is there any possibility that I might see some accounting that adds up correctly?

When is the Beneficiary going to be repaid for the four years he's been entitled to receive funds for utilities that never made their way to the Beneficiary's hand?

You owe \$2508.00 in unpaid utilities and counting. When can the Beneficiary expect to receive funding for utilities Home for Good have been claiming on his behalf (allegedly) for the last four years?


I look forward to hearing from You and some honest answers. Documents that show accurate accounting Will also be appreciated because these documents don't add up.


Is any One going to be criminally charged, or is this an 'acceptable' level of fraud and criminal malfeasance for Your office, Jason?

Those funds should NEVER have come out of the basic needs portion of the Beneficiary's Benefits.

How is it possible for some One working so close with You to be ignorant of what the Housing subsidy covers and what the Beneficiary is Entitled to receive unless You were using the consent provided to exploit him for Your own personal gain?

Tell Me how it's possible for Lili to be learning about all of this for the first time.
