You Will notice that the Entitlement Form CLEARLY states that the subsidy amount awarded is the cost of My rent, PLUS apartment insurance, PLUS utilities, MINUS the \$390 shelter cost from OW.

Either way, MHI is receiving an extra \$60 a month for 'utilities', and they have never paid any utilities for the Beneficiary EVER. I believe that Kelly Kritsch from the city of Ottawa is complicit in the grift. Also note that the utilities portion paid is to include receipts as attachments to prove the amounts. There were no attachments to show how much they are paying for 'utilities' because they are not paying any utilities, they are putting the money in their own pocket.

Is there any One I am required to report the fraud of the City of Ottawa and Multifaith Housing Initiative? Should I be reporting this to the police as well, or Will You take care of that.

Please see attachment for evidence of the fraud. They have already stolen \$60 this year. Sarah Lorenz is the manager from MHI who was engaged in fraud previously, though she insists she repaid the stolen money. We both know that the stolen money was only returned last week. Thank You for confirming receipt, I but I perceive Your email to be additional gaslighting. This is clear and obvious fraud on its face! This is not an accident. They are completely fudging numbers so that they can pocket money they are claiming to pay



that the Beneficiary is paying from the basic needs allowance. This has been ongoing every year I've received a receipt, I've found MHI to be in possession of more funds than they were authorized (by Me in a meeting at Ontario Works) to receive. The form clearly states that apartment insurance and utilities are included in the subsidy the Beneficiary is Entitled to. I have a lot more 'utilities' than just hydro. You are going to pay ALL My utilities - phone, hydro and internet.

Now... MHI must have a copy of these documents as well, I want to see the 'receipts' they provided to support this application for Entitlement. I also Wish to see these People criminally charged because this not a civil offence, these acts are criminal. Theft of public money and there is no Way that they are claiming \$60 more than what they actually pay 'by mistake'.

Every single person receiving a subsidy from the City should receive an 'Entitlement Form' like the one I received this year, every year. No One else in My community has EVER received any kind of receipt to show what MHI is taking for rent, and they gaslight and ignore requests for receipts while they are stealing from the public Trust.

I want these People criminally charged and a full forensic audit done on every subsidy approved by the City for MHI because I believe they are inflating the amounts they are entitled to receive for everyone!

I have included a photograph of the form I received and forwarded My emails to Ontario Works to You so that You can see how I'm responding to their fraud.

I'd like to see the 'attachments' they are relying on for the \$60 utilities, and yes, I would prefer You take care of this as soon as possible, so dealing with Kelly's 'cover over' is sufficient so long as she can produce the required documents.

There was a payment made for money MHI stole last year in the amount of 1018.00. I've been very clear about which form it is I am as King of You for. I am also being very clear about the fact that Ontario Works owes back pay for every single payment for utilities that was taken from the Beneficiary's 'basic needs' portion of his Ontario Works Benefits.

The 'formula' for calculating subsidy the Beneficiary is Entitled to receive from the Housing Authority is as follows"

Actual Shelter Cost + Utilities + Insurance - Social Assistance Shelter Allowance  
=\$1132.00 + \$0.00 + \$0.00 - \$390.00 = \$742.00 (not \$802.00 as claimed)

I don't know how long HFG and MHI have been fudging numbers to steal extra money from the Beneficiary's Trust, We only know that they are claiming to pay \$60.00 more than what they actually require for the coming year and the last two months so far. The Beneficiary is entitled to have those funds for hydro returned to him *with interest* sufficient to offset the depreciating value of the dollar.

We also know that the utilities have been paid entirely out of the 'basic needs' portion of the Beneficiary's Ontario Works Benefits for the last five or six years - somewhere between \$600/annum and \$720/annum depending on the year. This was despite his protests to Orsolya Vancsody, advising her that utilities and apartment insurance are part of the housing cost and should not come out of the basic needs portion of the



Beneficiary's check because then they won't have sufficient wealth to provide for their basic needs (which do not include insurance or utilities) in violation of their inherent rights.

Not only was I correct in My assertions to Ontario Works and Home for Good, it appears You have known this very well and were taking advantage of the Beneficiary by claiming to pay those amounts Yourself while putting the money in Your own pockets, and at the Beneficiary's expense.

The landlord has not provided a single receipt for rent upon request in violation of the Residential Tenancies Act and it appears they have been concealing receipts to protect their fraud.

Is any One going to be charged criminally? Or are state actors breaching the public trust with malicious intent immune from criminal prosecution?

I believe You are stalling, Genevieve. I don't believe for one second that You don't already have a copy of the supporting documents provided with this form to the Housing Authority unless You are conceding that HFG and MHI are guilty of more destruction of evidence and documents necessary for litigation which is just another criminal Act.

Where is the form that HFG submit to support their application for subsidy? They are required to maintain a copy of the documents they provide for subsidy for a *minimum* of seven years. It should not take more than five minutes for You to request these documents from Kelly the Criminal Kritsch's understudy and she Will either produce them for You, or she Will be obstructing Justice and a criminal investigation.

Mathieu, I am also as King for an internal review to have all payments made to Ottawa Hydro from the Beneficiary's 'basic needs' portion returned to him with interest as soon as possible if You are not already in the process of making that happen. If You are in the process of returning those funds, please provide Me with an ETA.

Finally, the payments to Ottawa Hyrdo MUST continue at the rate of \$60 per month as claimed by Housing Services. They are receiving those funds and claiming to pay those funds, so they Will do as they are telling the Housing Authority they are doing or You are further aggravating the harm by supporting their fraud.

I need some answers please. When can the beneficiary expect to have the payments for utilities returned to him, and when can I expect to receive a copy of the form that was provided to the Housing Authority to support the payment of utilities?

I included You on this Matter because I expect HFG and MHI to 'gaslight' - fail to respond to My emails altogether, or respond without addressing any of the Issues. What I am asking of You for, is a copy of whatever MHI provided to the Housing Authority. This should not take days or weeks to produce because Your client (HFG) is required by law to maintain accurate records of the applications they are making to the Housing Authority for subsidy. I Wish to see the form they used to support their fraudulent claim that they are paying \$60 in utilities. I also very frankly believe that it was You who told Ontario Works to short the shelter allowance portion of Benefits to offset the funds Your client is fraudulently claiming to pay. But as a result of all the confusion and tampering with documents, it appears as though the landlord was shorted \$2. rent for the month of August because it should have been \$304.00 and \$356.00 if You were hoping to offset the amount the landlord was planning to steal.

It also appears as though You are hoping to cover over their fraud by simply reducing the amount that Ontario Works is paying to offset the fraud. That is not acceptable. I have been telling Ontario Works, HFG, Orsolya Vancsody and every One else at Ontario Works that Housing costs include utilities and rental insurance. That has now been proven true by Way demonstrable causality.

Being housed should not cause additional economic harm to the Beneficiary or his ability to provide for his basic needs, as that would be 'Contra Bonus Mores' and defeating the purpose.

You have all been given My consent to communicate between You to ensure that the Housing Subsidy is never again revoked, and You have used My consent to obtain information that You have used to Your advantage at the expense of the Beneficiary.

I don't believe You are acting in Honour. Lili Mukalay has reduced the shelter allowance of OW Benefits the Beneficiary is entitled to receive from the province to offset the additional \$60.00 the landlord was hoping to pocket by claiming they are using those funds to pay the Beneficiary's hydro utilities. The Entitlement Notice clearly states that the Beneficiary is Entitled to claim utilities and rental insurance as part of the subsidy so

long as the total subsidy does not exceed 80% market value rent, and those amount have already been approved for the 2025-2026 period but You are not doing with those funds what You are claiming to do with them.

The only way to correct this wrongdoing is to make sure that the Benefits that were approved are used for the purposes claimed in the application for subsidy. I don't believe You are acting in Honour. Lili Mukalay has reduced the shelter allowance of OW Benefits the Beneficiary is entitled to receive from the province to offset the additional \$60.00 the landlord was hoping to pocket by claiming they are using those funds to pay the Beneficiary's hydro utilities. The Entitlement Notice clearly states that the Beneficiary is Entitled to claim utilities and rental insurance as part of the subsidy so long as the total subsidy does not exceed 80% market value rent, and those amount have already been approved for the 2025-2026 period but You are not doing with those funds what You are claiming to do with them.

The only way to correct this wrongdoing is to make sure that the Benefits that were approved are used for the purposes claimed in the application for subsidy. If You are NOT going to immediately start paying \$60.00 in utilities including backpay for the last six years the Beneficiary was entitled to same, You are effectively aiding and abetting fraud and helping to cover over the fraud with more fraud and theft of public money - this time from the Province.

The subsidy is not provided by the City because Ontario Works pays out too much in shelter costs to Beneficiary's of Ontario Works, the subsidy is provided because the City of Ottawa recognized the shelter portion of OW is not sufficient to secure an apartment in the City of Ottawa. They don't provide shelter subsidy so that You can reduce the amount the province is legally obliged to pay - that is just more fraud.

produce because Your client (HFG) is required by law to maintain accurate records of the applications they are making to the Housing Authority for subsidy. I've been very clear about which form it is I am as King of You for. I am also being very clear about the fact that Ontario Works owes back pay for every single payment for utilities that was taken from the Beneficiary's 'basic needs' portion of his Ontario Works Benefits.

The 'formula' for calculating subsidy the Beneficiary is Entitled to receive from the Housing Authority is as follows"

Actual Shelter Cost + Utilities + Insurance - Social Assistance Shelter Allowance

= \$1132.00 + \$0.00 + \$0.00 - \$390.00 = \$742.00 (not \$802.00 as claimed)

I don't know how long HFG and MHI have been fudging numbers to steal extra money from the Beneficiary's Trust, We only know that they are claiming to pay \$60.00 more than what they actually require for the coming year and the last two months so far. The Beneficiary is entitled to have those funds for hydro returned to him *with interest* sufficient to offset the depreciating value of the dollar.



We also know that the utilities have been paid entirely out of the 'basic needs' portion of the Beneficiary's Ontario Works Benefits for the last five or six years - somewhere between \$600/annum and \$720/annum depending on the year. This was despite his protests to Orsolya Vancsody, advising her that utilities and apartment insurance are part of the housing cost and should not come out of the basic needs portion of the Beneficiary's check because then they won't have sufficient wealth to provide for their basic needs (which do not include insurance or utilities) in violation of their inherent rights.

Not only was I correct in My assertions to Ontario Works and Home for Good, it appears You have known this very well and were taking advantage of the Beneficiary by claiming to pay those amounts Yourself while putting the money in Your own pockets, and at the Beneficiary's expense.

The landlord has not provided a single receipt for rent upon request in violation of the Residential Tenancies Act and it appears they have been concealing receipts to protect their fraud.

Is any One going to be charged criminally? Or are state actors breaching the public trust with malicious intent immune from criminal prosecution?

I believe You are stalling, Genevieve. I don't believe for one second that You don't already have a copy of the supporting documents provided with this form to the Housing Authority unless You are conceding that HFG and MHI are guilty of more destruction of evidence and documents necessary for litigation which is just another criminal Act.

Where is the form that HFG submit to support their application for subsidy? They are required to maintain a copy of the documents they provide for subsidy for a *minimum* of seven years. It should not take more than five minutes for You to request these documents from Kelly the Criminal Kritsch's understudy and she Will either produce them for You, or she Will be obstructing Justice and a criminal investigation.

Thank You for confirming receipt, I but I perceive Your email to be additional gaslighting. This is clear and obvious fraud on its face! This is not an accident. They are completely fudging numbers so that they can pocket money they are claiming to pay that the Beneficiary is paying from the basic needs allowance. Theft of public money and there is no Way that they are claiming \$60 more than what they actually pay 'by mistake'.

Every single person receiving a subsidy from the City should receive an 'Entitlement Form' like the one I received this year, every year. I've been very clear about which form it is I am as King of You for. I am also being very clear about the fact that Ontario Works owes back pay for every single payment for utilities that was taken from the Beneficiary's 'basic needs' portion of his Ontario Works Benefits.

The 'formula' for calculating subsidy the Beneficiary is Entitled to receive from the Housing Authority is as follows"

Actual Shelter Cost + Utilities + Insurance - Social Assistance Shelter Allowance

= \$1132.00 + \$0.00 + \$0.00 - \$390.00 = \$742.00 (not \$802.00 as claimed)

I don't know how long HFG and MHI have been fudging numbers to steal extra money from the Beneficiary's Trust, We only know that they are claiming to pay \$60.00 more than what they actually require for the coming year and the last two months so far. The Beneficiary is entitled to have those funds for hydro returned to him *with interest* sufficient to offset the depreciating value of the dollar.

We also know that the utilities have been paid entirely out of the 'basic needs' portion of the Beneficiary's Ontario Works Benefits for the last five or six *years* - somewhere between \$600/annum and \$720/annum

depending on the year. This was despite his protests to Orsolya Vancsody, advising her that utilities and apartment insurance are part of the housing cost and should not come out of the basic needs portion of the Beneficiary's check because then they won't have sufficient wealth to provide for their basic needs (which do not include insurance or utilities) in violation of their inherent rights.

Not only was I correct in My assertions to Ontario Works and Home for Good, it appears You have known this very well and were taking advantage of the Beneficiary by claiming to pay those amounts Yourself while putting the money in Your own pockets, and at the Beneficiary's expense.

The landlord has not provided a single receipt for rent upon request in violation of the Residential Tenancies Act and it appears they have been concealing receipts to protect their fraud.

Is any One going to be charged criminally? Or are state actors breaching the public trust with malicious intent immune from criminal prosecution?

I believe You are stalling, Genevieve. I don't believe for one second that You don't already have a copy of the supporting documents provided with this form to the Housing Authority unless You are conceding that HFG and MHI are guilty of more destruction of evidence and documents necessary for litigation which is just another criminal Act.

Where is the form that HFG submit to support their application for subsidy? They are required to maintain a copy of the documents they provide for subsidy for a *minimum* of seven years. It should not take more than five minutes for You to request these documents from Kelly the Criminal Kritsch's understudy and she Will either produce them for You, or she Will be obstructing Justice and a criminal investigation.

Every single person receiving a subsidy from the City should receive an 'Entitlement Form' like the one I received this year, every year. Good morning, every One!

I couldn't help but wonder what the City of Ottawa's legal counsel Will have to say about Home For Good and Multifaith Housing Initiative' constructive fraud. I have been telling the City of Ottawa via both Home for Good and Ontario Works that utilities and rental insurance are part of the housing allowance portion the Beneficiary is Entitled to and that it those additional expenses One incurs by obtaining housing should not affect the 'Basic Needs' portion of funds received by the Beneficiary.

Also, You Will note that there are no 'attachments' to verify the amount that MHI is receiving for utilities, and they also lied to Me about the cost of My rent. Last form I received showed that rent is \$1142.00, not \$1132.00 as claimed in the Entitlement form, though You are receiving \$1192.00, falsely claiming that \$60 of that money is paying My utility costs.

I presume that the reason MHI and HFG do not provide receipts to any One in receipt of subsidy is because they are doing this with every One - double booking; claiming to pay costs that are in fact coming out of the basic needs portion of Ottawa's most marginalized minorities dependent on corrupt state Actors for their basic subsistence and in violation of international Law.

Does the City of Ottawa's lawyer have anything to say about this? I'd like the \$60 that was stolen from Me for the month of June returned to Me, and I would like to see the 'attachments' the city is relying on to support this 'Entitlement Notice'.

I look forward to hearing from You, Gen! No wonder the City of Ottawa has so many liars posing as lawyers, the entire city seems to be working some kind of grift against Canada's People. These criminal clowns must keep You very busy.

I recently received the attached document from 100 Constellation Avenue. You Will notice that the Entitlement Form states that I am to provide You with a copy for My Records. I'm reporting five counts of fraud because I'm supposed to receive one of these forms every year - this is the first time I have ever received one.

More alarming still, MHI and HFG are claiming to pay exactly \$60. in UTILITIES which are included in the subsidy amount the Beneficiary is Entitled to receive - same applies to Apartment in insurance. Apartment insurance and utilities are part of the 'House Allowance' portion of Ontario Works and should NOT EVER be taking from the Beneficiary's basic needs portion or they don't have sufficient wealth to eat.

You Will notice that the Entitlement Form CLEARLY states that the subsidy amount awarded is the cost of My rent, PLUS apartment insurance, PLUS utilities, MINUS the \$390 shelter cost from OW.

Either way, MHI is receiving an extra \$60 a month for 'utilities', and they have never paid any utilities for the Beneficiary EVER. I believe that Kelly Kritsch from the city of Ottawa is complicit in the grift. Also note that the utilities portion paid is to include receipts as attachments to prove the amounts. There were no attachments to show how much they are paying for 'utilities' because they are not paying any utilities, they are putting the money in their own pocket.

Is there any One I am required to report the fraud of the City of Ottawa and Multifaith Housing Initiative? Should I be reporting this to the police as well, or Will You take care of that.

Please see attachment for evidence of the fraud. They have already stolen \$60 this year. Sarah Lorenz is the manager from MHI who was engaged in fraud previously, though she insists she repaid the stolen
