Dear Shawn,

I mentioned that I'm also a Free Lance Journalist reporting on the corruption of State Actors and Canada's compromised Courts because I believe this is a Matter of great public interest - especially the Ottawa Police cover up of the investigation into the mRNA bioweapons posing as vaccines, concealing critical information pertaining to the risks and dangers to their unborn children - that was after *nine mothers* reported losing their unborn child after receiving the covid bioweapon posing as a beneficial medical product.
