Please take Notice that the two 'discontinuances' dated **Jan. 3rd, 2024**, shows it was allegedly served upon the 'Estate of Joachim von Dehn' and Tiffany Singh at 1070 Hewitt Street, Gravenhurst Ontario.

Please bear with Me because I find this rather odd considering (according to Your affidavit testimony) the property at 1070 Hewitt Street Gravenhurst, Ontario was sold in the late part of 2021, right?
