Dear Geneviève and Mathieu,

Please note that last month, \$390. was deducted from the Beneficiary's Housing Allowance portion but only \$356. was paid to the landlord. *The difference was added to the total amount the Beneficiary is Entitled to receive* - so don't even try to tell Me I am incorrect.

If the landlord is only taking \$302. of the \$390. the Beneficiary is Entitled to, the difference is added to the total amount the Beneficiary is Entitled to receive. It should look exactly as the cheque for last month did. My belief, is that You are Giving these surplus funds to MHI or HFG. The Ontario Works Act specifically states that essential utility costs should be part of the shelter cost and should not affect the Basic Needs portion the Beneficiary is Entitled to. OW owes Me *a lot of money* in back pay for utilities!

What should be happening (and should have started from the day I advised Orsolya Vancsody that apartment insurance and utilities are included in the shelter allowance portion the Beneficiary is Entitled to receive), is the amount should show 'pay direct utilities' and 'pay direct rent' as \$60. and \$330. respectively, *for a total of \$390.* The 'Entitlement Form for Housing Allowance' should show \$1142. + \$0. - \$390. for a total Entitlement of \$752.00 which would include the Beneficiary's \$60. Hydro expense. That's STILL \$50. less than what they are scheduled to receive from the Housing Authority based on the information they provided in their fraudulent claim.

Are We all on the same page here? I sometimes can't help but wonder if You are trying to help Me become one of the most infamous independent journalists on the planet, because I'm hard pressed to find any One who has exposed anywhere near as much government corruption as I have, and You seem to just continue to dig deeper, and deeper holes for Your Self.

Where are the 'supporting documents' that were provided with the Entitlement form, and who were they provided by?
