The Entitlement form for THIS YEAR shows that the Beneficiary is entitled to receive \$60. in utilities he is NOT receiving. The Entitlement forms provided to Me show that MHI received \$60 for utilities from June 2021 to now and those utilities have been approved AGAIN until *June of 2026* - the Beneficiary is Entitled to receive those Benefits and EVERY penny hat was paid out from his basic needs for utilities since he's been in receipt of the subsidy - THAT IS WHAT THE ENTITLEMENT FORMS CLEARLY SHOW HE WAS ENTITLED TO RECEIVE.

Staff at Ontario Works and Home for Good LIED TO THE BENEFICIARY and said those were not part of his housing cost and that he was not entitled to subsidy for them while You were claiming them on his behalf and paying them to the landlord.

Staff advised me that the Home for Good program takes into account utility expenses and insurance costs as part of the benefit calculation if these are submitted as

In your case, they explained that:

- Your rent amount is \$1132
- · Your utility expenses: \$60
- Your OW Shelter Portion is \$390
- Your monthly housing benefit (with utilities included) is therefore \$1132 + \$60 \$390 = \$802

As the City pays \$802 directly to your landlord, the remaining balance for your rent and utilities is \$390 (paid by OW). \$330 of the OW amount is paid directly to your

If your utilities are not paid directly to your hydro company or not being incurred, it is my understanding that OW and the Rent Supplement Office need to know this. A (and OW) to have a recalculation of your benefit.

If the calculation does not include the \$60 for utilities, your monthly benefit would be reduced to \$742. You would then be required to pay any utilities or insurance cost which includes the summary/accounting from July 2023 to February 2025 when your hydro costs were being deducted from your basic needs. I am providing clarification regarding your Ontario Works (OW) accommodation and utility entitlements.

Accommodation Entitlement

For a single person, the maximum accommodation amount is up to \$390 per month. At present, your rent (combined with your Rent Supplement) is \$302. This leaves a balance within your &

Effective November 2025, your rent is expected to increase to \$330, leaving \$60 to cover either Hydro or tenant insurance or both, based on the cost after you provide verification.

Hydro Payments

You had shared with your case worker that you have a credit on you Hydro account. If this is not correct, please provide a copy of your most recent bill so we can verify.

Previously, OW made monthly Hydro payments of \$60 on your behalf, based on an earlier estimate obtained when we paid arrears directly to Hydro. However, given your current credit balancupdated bill and your consent to verify this information with Hydro. If the credit was generated from the \$60 payments, it is likely your actual monthly cost is now lower than \$60.

Rental Insurance

If you wish to receive assistance with your rental insurance, please provide verification of the expense, as we may be able to cover this from your accommodation entitlement, provided there i

Pay-Direct to Landlord

You have requested that OW stop making Hydro payments directly to the vendor on your behalf. Please be aware that OW previously paid arrears on your behalf, and if you choose to remove

If you have any further questions or wish to proceed with these changes, please ensure you provide the required verification documents so we can update your file accordingly.

I would like to add that while you are welcome to raise your concerns, I must insist that you do so in a courteous manner. However, I must also note that you have used hostile, abusive, and c

Dear Genevieve,

As I stated in my previous email, the Beneficiary was entitled to receive utilities from the day he obtained housing and Ontario Works LIED about that and the rental insurance. That's why the apartment insurance was discontinued after the first year because the Beneficiary did NOT consent to those funds being deducted from his basic needs.

Sean is entitled to receive every penny he paid from his basic needs for utilities returned to him. The Entitlement forms clearly showed that the landlord was receiving \$60/month the entire time the Beneficiary was paying those funds from his basic needs. The accounting provided is NOT a total accounting of what the Beneficiary paid in utilities which is what You said You were going to provide receipts for.

Again, the Entitlement forms show that the Beneficiary is entitled to receive utilities for \$60 July, August and September that HE HAS NOT RECEIVED. They ARE to be paid directly from the shelter portion of benefits, they have instead REDUCED THE AMOUNT TO \$302.00 to offset what they were planning to STEAL!!!

They should not have STOPPED the automated payments, they should have transferred them to the shelter portion so that the amounts reflect what was awarded to the Beneficiary in the Entitlement forms or You are guilty of fraud by definition.

The Beneficiary paid out a lot more than \$1018.00 in utilities since 2021 and he was entitled to those benefits from the beginning. The only reason he didn't receive them is because Ontario Works LIED and said he was not entitled to claim them while they gave them to his landlord!!!

Do you need to see the entitlement forms again!? He has not received the utility benefit for the last three months and has paid it out of his own pocket!!!

I have seen this receipt and it is a fraud, it does NOT explain the total amount of utilities paid from the Beneficiary's basic needs which SHOULD NEVER HAVE HAPPENED!!! Those funds should have come from the automatic payment from shelter costs as You said in Your email, not from his basic needs. Every penny deducted from basic needs is what the Beneficiary is entitled to receive from the time he acquired housing until at least june of next year

Do I need to get a lawyer or Will You provide Me with the receipts You promised?

I honestly don't know what is so difficult to understand. You actually said EXACTLY what I told Lili Mukalay SHOULD have been done starting July 2025, which is...

"As the City pays \$802 directly to your landlord, the remaining balance for your rent and utilities is \$390 (paid by OW). \$330 of the OW amount is paid directly to your landlord by OW and the remaining \$60 is paid to hydro for your utilities."

EXACTLY!!! But that is NOT BEING DONE, GEN!!! I don't know what part of that You don't understand. Instead, they are paying ONLY \$302. because rent doesn't ACTUALLY go up until December 1st, at which time the plan to pay \$330.00 while the Beneficiary continues to pay utilities out of his own pocket!!!

They DID NOT pay \$60 in utilities for July, August. September, that is being deducted from the credit the Beneficiary is owed by Hydro to reimburse what was taken from his BASIC NEEDS!!! Again, the ENTIRE TIME the Beneficiary has been entitled to have his utilities and rental insurance paid. The Beneficiary CANCELLED the rental insurance because Ontario Works said it could NOT be claimed and would come out of his basic needs along with utilities. That was a lie.

If the Beneficiary is entitled to receive \$60.00 in utilities when rent is \$1132.00, then he was entitled to receive utilities when rent was only \$950.00, wasn't he?

Home for Good and Ontario Works lied to the Beneficiary about what he was able to claim as part of his housing allowance. He is entitled to compensation for the entire time You lied to him.
