Dear Kelly,

I understand Your position on the Matter but believe the entire situation is entirely unacceptable regardless. You are correct, it is obvious that Lili *should* be able to comprehend what We are as King of her for - she is clearly stalling or sufficiently incompetent that she should probably be removed.

The problem for Me is that despite the fact that Ontario Works is legislated by the province under the Ontario Works Act, all three of the organizations conspiring against the Beneficiary (Ontario Works, Home for Good and Multifaith Housing Initiative) are Trusted to fulfill fiduciary obligations to Ottawa's People by Way of the services they provide. They are all City of Ottawa employees.

All public servants are bonded. You've all breached the public Trust which is a serious, criminal offense especially when perpetrated by a public servant. If any One involved has failed to advise their insurance provider that there is a claim upon their performance bond for breach of Trust, You Will not be entitled to the insurance it provides and Will be civilly and criminally liable in Your personal, private capacity because insurance protection does not allow One to engage in criminal conduct.

So the City of Ottawa is going to be civilly and criminally liable to Me for Lili Mukalay's refusal to provide the receipts We are as King for, rather than hold Lili Mukalay responsible for obstruction of justice, breach of Trust, and fraud with malicious intent to withhold benefits that beneficiary of the public Trust is Entitled to receive, and for which the three of You have happily been providing to the landlord Multifaith Housing Initiative instead?

When one or more individuals are found to be conspiring against another, all parties involved in the conspiracy are jointly and severally liable. This means that rather than sue the City of Ottawa, You are suggesting this is all Lili Mukalay's fault because 'the City of Ottawa' would love to Give the Beneficiary the funds he was Entitled to but Lili won't tell any of You how much that is, so Your hands are tied?

Am I understanding You correctly? If Lili Mukalay would just be forthcoming with how much the Beneficiary has paid from his basic needs for utilities, You would immediately ensure that money is repaid to the Beneficiary, minus the \$1018 already received. Is that correct?

Please confirm. I have made a second application for a legal aid certificate to make a claim for what I am owed according to the Entitlement forms provided to Me.
