Good morning, Virtual Crown,

I was instructed to send all communications for the prosecutor in relation to this file number to this email address. I look forward to hearing from the prosecutor at his earliest convenience. I have several details concerning his information that I Wish to discuss with him.

Please ALSO be advised that according to the Rules of Criminal Procedure:

Rule 4:

Court Documents Format 4.01

- 1. (1) Every document in a proceeding shall be:
- 2. (a) in 12-point or larger font;
- 3. (b) double spaced, except for quotations longer than four lines and footnotes; and,
- 4. (c) be divided into a single series of consecutively numbered paragraphs.
- 5. (2) All documents shall be **electronic**, except where a self-represented person does not have access to electronic means, in which case paper copy materials will be accepted. (3) All electronic documents shall use bookmarks and hyperlinks as set out in the Consolidated Provincial Practice Direction for Criminal Proceedings.

So I **should** be receiving a copy of EVERYTHING that has happened related to this case file ELECTRONICALLY - by email.
