Providing Me with everything BUT what I am as King for, is NOT acting in Good faith, it is CONTEMPT.

If You continue, I Will believe Your INTENT is to delay and cause harm to the Beneficiary which makes Your criminal negligence criminal *intent*.

Now, Will You Act in Good faith, or are You just a bunch of criminals?

I'm waiting for those receipts. Evidence of gaslighting is attached for Your Records.

If Lili and Kelly Wish to keep gaslighting, I Will presume their intent is criminal and that they Wish to be charged and go to jail for breach of Trust with malicious intent to cause economic harm to a Beneficiary of the public Trust.
