What are You talking about?! 'PAY DIRECT' for what?!

Look at these Entitlement Forms and do some basic math with Me. In 2021, when the Beneficiary was living on Kent, he was told that utilities and rental insurance were NOT included and COULD NOT be claimed as part of the shelter/housing cost for subsidy.

These forms show that was a LIE!!! That is a BREACH OF TRUST, KELLY!!!

So, the Beneficiary SHOULD have been receiving \$60/month every month he was paying that amount for utilities because he's been paying it since he acquired housing and was entitled to claim it as part of his housing cost. Instead, You have taken those funds from his basic needs and given the money to his landlord instead by breaching his Trust and using the consent that was provided to You to learn how much he was paying in utilities so You could give that money to My landlord instead?

And now You want Me to Trust You with consent for what? I consent to You finding out EXACTLY how much the Beneficiary has paid in utilities because he is entitled to every penny back!

Ontario Works has REDUCED the shelter portion of Benefits this year to offset the amount that You are NOT paying to the Beneficiary for his utilities and were previously planning to give to the landlord.

Please confirm what You are as King of consent for and tell Me why I should ever Trust You with anything?

Your own forms show that MHI received \$60x12 for 2023, 2024, 2025 and have been approved the same amount until June of 2026.

Simple math, Kelly. $\$60 \times 12 = \720 (one year). $\$720 \times 3 = \2160.00 . $\$2160 - \$1018 = \$1142.00$ not including $\$60 \times 3 = \180 for July, August and September of 2025.
 $\$1142. + \$180 = \$1322.00$

Sean was also Entitled to receive Benefits for 2021 and 2020 - ever since he acquired housing because You were *lying to him when You said he could not claim those costs!!!*

You owe Sean every penny he has paid out in utilities from his basic needs - period.
You have My consent to find out how much that is and pay him what You owe him!!!

Hi Kelly,

The attached document is a table showing Ontario Works eligibility for a single individual, as well as the amounts sent to the landlord and/or hydro.

Ontario Works has received a cheque from Multi-Faith in the amount of **\$1,096** to reimburse the City for the overpayment made on behalf of the client, covering the period from **July 1, 2023 to February 2025**.

An assessment and adjustment were completed on the client's Ontario Works file to ensure the reimbursement was applied accurately to the months in question. This was based on the amounts paid by both Rent Supplement and Ontario Works to the landlord, in alignment with the rent costs for those months.

Following the adjustment, an overpayment of **\$78** was identified as owing by the client to Ontario Works. This amount was deducted from the reimbursement, resulting in a net amount of **\$1,018** returned to the client.
