
Further to previously provided disclosure, attached you will find a further disclosure package. Also included is the Charge screening form that includes the name of the assigned crown.

I've been as King of Crown Attorneywhy these charges are not showing up in the Court Case Look up tool and Virtual Crown is REFUSING to provide Me with an answer and REFUSES to provide their first and last name as clerks of the Court which I consider to be contempt and obstruction of justice when the Crown is engaged in fraud.

I believe My rights to a legitimate proceeding and a Superior Court of inherent Jurisdiction are being denied in violation of My rights.

I have filed a Form 1 Application to Dismiss as Frivolous, Vexatious and an abuse of Power for Registry Fraud and an egregiously biased police investigation that was set up to have a predetermined outcome, and fraud in Melina McDougal's investigation materials (she created the 'synopsis' file on March 21, 2024 and includes in her synopsis details of events taking place on March 22, 2024). Obviously, if the date the information was Created is true, then none of the information created on that date can be true if the events exist in the reports future.

Blessings, please let Me know if I have filed the Form 1 Application correctly and can You help Me find a name for prosecution to accept full Civil and criminal liability for the gross prosecutorial misconduct?

After the motion to dismiss for fraud and vexatious litigation, I Will bring a Motion of Counterclaim for civil and criminal liability against each of the accusers conspiring against Me.

Please also be advised that the arrest of Wednesday comes just after landlord MHI was discovered to have been stealing over \$2880.00 in utilities awarded to him in subsidy and intended for the Beneficiary.
