Good morning!

Mathieu, You have not Honoured the Benefits the Beneficiary was awarded by the Entitlement Notice he received. You Will please take SPECIAL NOTICE that the Entitlement Forms specifically state on the form that I am to provide a copy to the case worker at Ontario Works to let You know what I am Entitled to receive for subsidy.

You do not have any legislative authority whatsoever to deviate from what has been approved for the Beneficiary by the Housing Authority. You do not have any power or authority whatsoever to reduce or change any of the amounts. If You believe You do not have to Honour Benefits that the Beneficiary is Entitled to receive, please state the reason You believe that You have to refuse to provide the Beneficiary with the funds he has been approved to receive to help support his housing costs, including utilities and rental insurance.

To add insult to injury, You all LIED TO ME!!! You said that the Beneficiary is NOT Entitled to receive rental insurance costs and utilities as part of his housing subsidy from Home for Good while You were providing that information to the Housing Authority so that they could claim those funds and Give them to My landlord.

That's not just fraud, that's racketeering, money laundering, egregious breach of Trust. And You still need to find a Trust Instrument, a Trust Declaration, a Writ of Mandamus for Health Care and a Letter of Attorney which were all provided to case workers of Ontario Works for the Beneficiary's case file.

Spoliation of documents (loss or destruction) is also obstruction of Justice, fraud, breach of Trust and theft of public money if those documents have been destroyed to cause harm to the Beneficiary.

Now, if You provide Me with a full accounting of what You have unlawfully taken from the Beneficiary's basic needs for utilities and agree to pay those funds back to the Beneficiary immediately, I Will consider waiving criminal charges against each of You. If I don't hear back from You today (Monday) and find the money You stole from Me in the Beneficiary's account, You are guilty of fraud.

The attached forms show You what I am legally entitled to receive for Benefits. Those are legally binding documents. You both best be ready to explain to a Judge why You

feel You do not have to Honour the Entitlement Forms telling You what the Beneficiary is Entitled to receive. The instructions are on the forms in black and white.

Mathieu, if You Wish to collude with Your criminal supervisor, Lili the Malevolent Moron Mukalay, You Will go down with her. 'Just following orders' is not a lawful excuse for engaging in criminal conduct. You know what the Entitlement Forms say as much as Lili does. You Wish to gaslight Me and steal from Me by not making sure I get the utilities I'm entitled to receive, I Will bring You into Court against Your performance bond for breach of Trust and TREASON. You are literally stealing from Me in violation of a legal letter telling You what I am lawfully Entitled to receive.
