Dear William Coyte,

For now, You Will be William 'the Courteous' Coyte on My Blog for the International Court of Record. I sincerely appreciate the time You spent with Me on the phone today.

Having said that, I am going to let You know that I still feel there are some serious problems with the excuses You provided to Me for the contempt and silence I have experienced in replies to My queries to this email address. One of My email requests is simply titled '23-353404 - Requisition for Court of Record'.
