Dear Ariane,

I hope and Trust this email finds You well. I am very disappointed in You. You sounded like an absolutely upstanding, honourable individual who would never attempt to screw some One over or jeopardize Your career as a lawyer or public defender by using the Courts You work for as a cloak for fraud and malicious prosecution in bad faith.

I don't think You Wish to have Your photo posted all over the internet advising People that You are a corrupt criminal who is not interested in defending the constitutional rights of Canada's People and ensuring they receive a fair and impartial PUBLIC hearing.

I know You are in communication with some very serious criminals who Wish to bring You down with them. There is only ONE official email address for Crown Attorney for Ottawa, and it is virtualcrownottawa@ontario.ca. Any One instructing You to tell Me to communicate with Crown through an email that was specifically created to engage in fraud and 'railroad' what You call 'self Presented litigants' is not doing You any favours, they are hoping to ruin Your career and make You complicit in their fraud.

Now... If You can't provide Me with a reasonable explanation as to why there are no charges for Me on any 'public Record', then You Will concede that Stephen Lichti is engaged in fraud and malicious prosecution with criminal intent.
