## Reporting Fraud on the Part of the OW Administrator - Criminal Breach of Trust

Dear Welfare Fraud Office,

You make it very clear how to report an individual who is receiving benefits in fraud, but You don't seem to have any forms for reporting theft of public money by agents of Ontario Works who are colluding together with the City of Ottawa's 'Home for Good' staff to find out how much the Beneficiary had incurred in housing expenses so that they can make an application for subsidy and hand those benefits over to the not for profit landlord (Multifaith Housing Initiative) at the Beneficiary's expense (the payments for utilities are automatically deducted from the Beneficiary's basic needs portion of OW).

The Beneficiary has received Entitlement forms for the last five years showing that he was Entitled to receive subsidy for utilities and rental insurance. Ontario Works agents lied to the Beneficiary and told him that utilities and rental insurance are additional expenses that are paid from the 'basic needs' portion of Ontario Works, depriving the Beneficiary of funds essential for his basic needs. Again, the entire time they are deducting these funds from the Beneficiary's basic needs, they are providing those expense amounts to City of Ottawa staff at Home for Good so they can claim those benefits in the subsidy application and Give it to his landlord instead, and at the Beneficiary's expense.

They were just caught and have effectively stolen more than \$3500.00 in utilities from Me, \$1018. of which they paid back voluntarily. Right now, Lili Mukalay has REDUCED the shelter portion of Benefits payable to the landlord to offset the money they were hoping to steal in utility benefits, rather than start paying the Beneficiary's utilities according to the Entitlement for subsidy awarded to him.

They should all be in jail but are instead gaslighting and REFUSING to provide receipts to show how much money they effectively stole from the Beneficiary.

I have reported the Matter to the SBT, they appear to be entirely complicit and say they have no authority or jurisdiction to take any action against public Trustees exploiting Beneficiaries with malicious, criminal intent. I believe this opinion is further criminal negligence aggravating the harm already done to the Beneficiary.

I look forward to hearing from You and for criminals posing as public servants exploiting beneficiary's to be held to account.

I need to know who is receiving these emails so I can report You to the appropriate authorities for aiding and abetting the theft of public money by the administrator. I can only presume whoever is in receipt of this email is complicit in their fraud.
