Good afternoon, Vicky,

I hope I've got the Magical Spelling of Your name correct, I spoke with You on the phone a couple of hours ago about a Matter concerning the Ontario Works Administrator for Sean Stephen von Dehn.

There is a phone conversation arranged for Thursday, October 30th at 11:30 in the morning with Charles who likes to go by 'Chuck'.

You were as King of Me if I have any additional documents for the file and I mentioned that I have the Entitlement Forms for subsidy which show that the Beneficiary was entitled to receive utilities as part of his housing cost through the Housing Authority and 'Home for Good' (the name of the program set up by City of Ottawa). These utilities were paid out to the landlord instead while Ontario Works lied to the Beneficiary about the Entitlement and deducted the same utilities from his Basic needs (rather than the shelter allowance portion of Benefits).

Even though they have received the Entitlement form for the 2025-2026 year, they stopped paying the utilities from basic needs and are refusing to honour the \$60. Entitlement for June through September of this year while the Beneficiary continues to pay those utilities out of pocket from his basic needs.

Dear Charles,

As I TRIED to explain to You on the phone, there is absolutely NO reason why Ontario Works should EVER be REDUCING the amount of shelter allowance a Beneficiary is entitled to receive unless the rent is LESS THAN \$390.00.

The ledger (attached) is what the landlord provided in the LTB documents to support an application to have Me evicted for non payment of rent (without any prior notice to Me by the landlord that the subsidy had stopped).

You Will take Notice that the amount the landlord receives is ALWAYS \$390.00 (the housing allowance portion) PLUS the amount the Beneficiary is ENTITLED to receive in subsidies for additional housing costs. The Entitlement forms attached to the previous email, show what the landlord was receiving IN ADDITION to the \$390 from Ontario Works, which does not only cover the cost of rent, but also \$60. extra for utilities which they determined by communicating with OW to find out how much I was paying from basic needs so they could Give those benefits to My landlord, while LYING TO ME and telling Me that utilities and rental insurance are not included in the housing subsidy, while the Entitlement forms tell a different story.

It may also be interesting for You to Note that I only received the Entitlement forms for the first time this year, and only because they were getting audited for another 'kickback scheme' reported by the CBC.

The entire time I have been receiving this benefit, OW has been deducting hydro from My basic needs (until June of this year, now I pay directly out of the basic needs I receive) and telling Me that it is not covered by the subsidy provided for by the City. They were simultaneously telling Home for Good how much I pay in utilities so they could claim that money in their application and Give it to My landlord instead?

I mentioned once that rent was unpaid to the tune of over \$10,000.00 and the city of Ottawa didn't even bother to tell Me! Why? Because they did it on purpose! I had to arrange a meeting with Lori Simpson to Sign the Entitlement form directly and advise that it is to never be revoked again for any reason without My express Writ of consent. I am the source of every penny You administrate as a result of Your fiduciary obligation to guarantee My rights and the source of every salary You pay out to 'State Actors' Trusted to Act in the best interest of Canada's People.

Now, Lili the Malevolent Moron Mukalay is REFUSING to provide receipts to show how much Ontario Works stole from My basic needs and FRAUDULENTLY claiming that I was not paying anything from My basic needs for utilities prior to 2023. I have been paying utilities since I acquired housing and I have been entitled to the benefit for exactly that long.

The receipts I have show that I paid out \$3025.00 from November of 2022 to present but I have to pay hundreds of dollars per month for every month of receipts I Wish to receive beyond 48 months, so I requested as much as I could afford, which was the last 48 months showing I've been paying utilities directly in the amount of \$60 and previously, \$55.00. There was never a time I have NOT paid utilities (including now) and I have been entitled to subsidy for those expenses since day one while Lili Mukalay continues to gaslight and suggest that I'm not - despite what the Entitlement forms state directly, and why I am 'required' to provide a copy to My case worker so they know what I am entitled to receive for subsidy (says so directly on the bottom of each form I did not receive for five years).

Failing to send Me a copy of the Entitlement form is also fraud by way of omission on the part of Kelly Kritsch and Home for Good staff who are absolutely belligerent and cut off subsidy without notice to People routinely!!

Dear Charles,

Please also read the attached email correspondences with Home for Good's Kelly Kritsch and Jason Cooke. I also include the City of Ottawa's lawyer on the email because she does in fact have first hand knowledge of how many times Home for Good have revoked subsidy without notice to Me, falsely claiming I didn't return renewal packages they deliberately didn't bother to send. In fact, last time, Kelly was so determined to prove that she served Me with a renewal package that she didn't actually send Me, she conspired with Canada Post clerks to fake My signature of acceptance. The actual receipt shows that the package was received by City of Ottawa employee 'D. Cote'. Ask Kelly about that anytime if You like, Beth Lambert of the Ombudsman for Canada Post confirmed every detail I am telling You here but determined Canada Post is not liable to Me for the fraud because the Canada Post Act 'clearly states' that Canada Post is not liable for packages not delivered as promised! Isn't that amazing!? We've legislated the right to engage in fraud!!! It's absolutely astounding.

Anyway... The City of Ottawa's lawyer knows, every One with half a working brain cell knows the City of Ottawa has been gaslighting Me for the last six years, deliberately trying to cause Me as much economic harm as they can, presumably because... I told them I believed I was entitled to have My utilities paid for by the City of Ottawa and Ontario Works and Home for Good told Me that wasn't true (2019/2020). But it's True when You can Give the money to the landlord instead, right? The moment I find out about it (June 2025), they STOP taking utilities from My basic needs forcing Me to pay them directly, then REDUCE the shelter portion of benefits to offset the utility benefits MHI was planning to steal, rather than just reduce the amount of subsidy they are issuing? The province doesn't have to pay its share because the landlord was planning to steal from Me? I don't get it.

We're as King of Lili Mukalay in Good Faith if she can just provide a copy of the receipts going back to 2019 when Sean first acquired housing and let's all take a real, honest look at how much Sean has been paying from his basic needs for additional housing expenses Home for Good was very happy to provide to the landlord MHI for the last six years. And now it looks like MHI is trying to have Me evicted for attempting to report their crimes and I'm absolutely confident that no One from the City of Ottawa is colluding against Me with them because what motive would they have to weaponize the Courts against Me? Not like Genevieve Langlais doesn't know a thing or two about violating the Rules of Civil Procedure, just as Steven Pardou at the Ottawa Superior Court Civil desk sometime - or Gillian Kreling for that matter!

Good morning Victoria and Charles (Chuck if You prefer),

I just Wish to point out that part of the reason for My frustration on the phone with Chuck the other day (Victoria told Me You prefer to go by 'Chuck') is because most of what We were discussing are NOT points of contention. The city of Ottawa HAS already conceded that I am and have been entitled to receive the subsidies as per the Entitlement Forms I provided to You from the time I obtained housing. They have acknowledged that I am Entitled to receive a rebate for the funds that were taken from My basic needs for utilities.

None of that is in contention. The last I heard on the Matter from Kelly Kritsch (Home for Good), is that essentially she is saying that they would be happy to reimburse Me but the funds were taken from My basic needs and should therefore be paid by Ontario Works and the province, not the City of Ottawa.

So We were as King of Lili Mukalay to please provide an accounting to show how much exactly that Sean has paid from his basic needs in automated utility payments so that he can receive the compensation he's entitled to. The total amount minus \$1018.00 is what is owed to the Beneficiary. We can't find out what that is because Lili Mukalay continues to produce documents of fraud which coincidentally happen to match exactly the same time period as the ledger MHI produced showing they were stealing money. They only paid back the amount shown in the ledger by MHI, though MHI was stealing from Sean the entire time according to the Entitlement forms.

Please get back to Me as soon as possible with an ETA and to let Me know if You require any additional information. I am comfortable with You sharing this email thread with Genevieve Langlais, the City of Ottawa's lawyer who generally just covers for the criminal negligence of City of Ottawa employees.
