Dear Melanie for Ottawa Hydro,

FINAL NOTICE OF CIVIL AND CRIMINAL LIABILITY: BREACH OF TRUST, HARASSMENT, BREACH OF PRIVACY (MFIPPA)

Is Your email I'm currently responding to Your reply to the attached Notice of Civil and Criminal Liability? I have REPEATEDLY requested FULL DISCLOSURE of all phone communications with agents of Ottawa Hydro for routinely LYING TO ME about the status of a credit balance, including falsely advising Me that the check is 'on its Way to Me' (October of 2025) when no such thing was done. It does not appear from My end

that there was any attempt to release the credit to Me, it was all just stall tactics and LYING to harass Me!!!

The check that was never actioned on the credit balance was requested a SECOND TIME at the end of December, 2025. It took You almost a MONTH to send it to Me after telling Me numerous times that it was NOT SENT because Ontario Works told You not to send it to Me? Some one by the name of 'Renee' at Ontario Works advised You NOT to send the payment?

Well, guess what Melanie? That proved to be another bold faced LIE!!! I have confirmed with Mathieu Regimbald at Ontario Works that there is no agent named Renee at Ontario Works in any capacity. Mathieu indicated to Me that he received a call from Ottawa Hydro on Monday of this past week, advising Me that HE DOES NOT HAVE MY CONSENT TO DISCUSS OTTAWA HYDRO WITH ANYONE WITHOUT MY EXPRESS CONSENT, AND REQUESTED MY PERMISSION TO DISCUSS THE ACCOUNT WITH YOU. I continued to withhold My consent and thanked Mathieu for telling Me that Ottawa Hydro had contacted Ontario Works without My knowledge and consent and routinely breaches My privacy and Trust by doing so.

You are claiming You are 'no longer allowed' to discuss My account with Ontario Works? When did You EVER have My consent to do so? I require the disclosure You have on file that states You may discuss My account with OW. One of Your agents claimed to have My consent 'on file' but I sure as hell didn't Give it to You so I would like to see receipt of that consent to discuss My account with third parties like OW. If You don't have it, that is another breach of Trust and fraud for telling tall tales not founded upon any facts.

You are hereby on Notice of Civil and Criminal Liability for Your belligerent reply to a Notice of Civil and Criminal Liability which I presume is what You are relying on as 'threats' against staff? No. Notice of Civil and Criminal Liability is not a threat, it is the first due process of law and a promise.

You Will take full liability in Your personal, private capacity if You attempt to characterize My actions as inappropriate ever again. There is nothing more inappropriate than criminal breaches of Trust perpetrated by a company fulfilling a public mandate and THREATENING Me with the loss of an essential service for advising You that I Will not tolerate Your breaches of Trust and agents REFUSING to provide their first and last name when they are criminally negligent and sharing My personal, private information without My consent or knowledge?

The check arrived WEEKS later than it was first promised to Me and You best retain ALL Records of all conversations with agents at Your office who are nothing but antagonistic, criminally negligent clowns. Only one agent in over six years of service was happy to Give her first and last name - failing to do so is obstruction of justice when it is requested for the purpose of litigation and I made it VERY clear that is the intent and purpose.

You Will now accept full liability in Your personal, private capacity for the criminal negligence of all Your staff and the refusal to provide Me with the disclosure I am as King for. I have also requested for You to ensure all payments are reported to the credit bureau which You are NOT doing and should be!

Please confirm receipt of this email, Your reply is not an appropriate reply to the attached notice of civil and criminal liability, it seems aggressive and retaliation for placing You on Notice and constitutes harassment. It is nothing short of professional 'gaslighting' as You have no addressed any of the points in My Notices to You!

Have a wonderful morning, I look forward to Your clarification on this Matter. If You are going to accuse Me of inappropriate conduct and threatening staff, You best be providing the disclosure of the evidence You are relying on or You are also guilty of obstruction, harassment and belligerent, antagonistic behaviour unbecoming of a legal professional.

I hope and Trust I am making My Self clear. You have until 5:00 PM before You Will be noted in default and this email, Your inappropriate reply to My Notice of Liability and any future replies, Will be published on the public Record at www.vondehnvisuals.com later today. That it is also a promise.

Addressing Me as 'Mr.' is also an offense on Record with MOJAG. MR is a position of public office- a position You are holding. I am not a public servant, I am a private person whose privacy has been violated by Your negligent staff who have no respect for the rules of engagement or My privacy.
