**Notice of Civil and Criminal Liability: Breach of Trust, Fraud, Obstruction of Justice and Letter of Demand**2 messages

Good morning,

According to the manager I spoke with yesterday, all My complaints to service agent managers have been forwarded to the 'legal department'.

I am as King for full disclosure of all 'notes' on the file and to preserve and forward to Me all recordings of calls with Your agents for the purpose of litigation. Every single agent I have spoken to at Ottawa Hydro REFUSES to provide their name when requested and has lied to Me *consistently*. 'Mary D.' who allegedly receives Your mail has accepted payments from Me and failed to credit them to the account. You are a criminal organization operating with impunity and in violation of the MFIPPA (Municipal Freedom of Information and Privacy Protection Act). Failing to provide first and last names of the agents involved is obstruction of justice as You are fulfilling a public mandate.

**Section 32 (Disclosure of Personal Information):** This is the core provision breached. An unauthorized disclosure occurs when information is shared in a manner not listed as a permitted exception (such as for a "consistent purpose" or law enforcement).

**Section 29 (Manner of Collection/Use):** If the information was used or disclosed for a purpose other than that for which it was originally collected, this section is violated.

**Section 48 (Offences):** If the disclosure was done willfully, it may be a violation of this section, which allows for fines of up to \$5,000 for improper disclosure.

I'll be as King for \$5,000.00 per offense and it appears as though every single agent I have ever spoken to at Ottawa Hydro breached My Trust. I require Mary 'D's last name for the purpose of litigation and obstruction of Justice. I can't Trust that she Will not destroy or spoliage documents I send to Your office. Please let Me know where I can serve You with documents.

Good day,

Please be advised that You have failed to meet the deadline and are now in default for Breach of Trust, Fraud, Trespass and Obstruction of Justice.

I am officially requesting full disclosure of all communications between My Self and all Ottawa Hydro service agents I have spoken with. I require a copy of the consent form You claim to have on file that allows You to discuss My Hydro Ottawa account with third parties without my knowledge or consent.

Failing to produce the disclosure I am as King for (including the first and last names of all individuals trusted with My personal, private information) Will be considered an additional Act of obstruction of Justice and fraud (by Way of omission, failing to produce documents necessary for the purpose of litigation).

You had until 5:00 PM yesterday to Honour Your Promise to Me, which was to have a check for the credit balance on the account sent to Me priority post and to be received no later than 5:00 PM, Friday, January 23rd, 2026.

This has to be *at least* ten times Your agents have lied to Me or failed to otherwise fulfill their promises to Me in Good Faith. I presume You are lying to Me to stall and delay litigation against You which is further obstruction and breach of Trust (continually lying to an individual about the status of their account is a serious breach of public Trust, as is withholding any evidence necessary for litigation).

You are hereby liable on behalf of Your agents and I am as King for no less than \$10,000.00 for Your continuous contempt and gaslighting. I have been advised that My complaint has been forwarded to the 'legal department' at Ottawa Hydro, and have been promised that all disclosure I have requested from telephone agents Will be sent to this email (I was told that on Friday the 17th of January), though I have not received so much as confirmation that the agent is telling Me the Truth - all I know for sure is how Good Your agents are at lying to Me, withholding their identity, and telling tall tales to string Me along.

You have until 5:00 Monday to provide confirmation of this email and that My complaint has been received by Your legal department.

I believe You are complicit in the City of Ottawa's 'kickback scheme' reported by the CBC and Wish to expose Your organization. If You are not complicit in the City of Ottawa's theft of public money and conspiring with corrupt slumlords, You Will respond to this email to advise Me otherwise. Right now, it appears You are a criminal organization with no respect for the Rule of Law and the privacy rights of Ottawa's People.
