I just got off the phone with a Man who claims to be a manager for Ottawa Hydro by the name of William Mengi.

I escalated a complaint to William Mengi regarding several agents of Ottawa Hydro discussing My Ottawa Hydro account with third party intervenors without My consent or knowledge. Even more concerning, it appears as though ALL of Your staff and managers, trusted with highly sensitive, personal, private information of clients have been INSTRUCTED by Ottawa Hydro management to withhold their name when it is requested for the purpose of liability?!

privacy and breach of Trust. Agents of Ottawa Hydro DO NOT have the right to withhold their name when it is requested, especially individuals One is compelled to Trust with such sensitive information.

Good day and thank You for Your reply,

I have had several 'service managers' at Ottawa Hydro advising Me that this complaint has already been sent to Your legal department and I have been waiting over two weeks for a response and for a check that never arrives. Your service clerks LIE repeatedly and REFUSE to Give their name upon request for the purpose of litigation

AFTER breaching My Trust and discussing My account with third parties without My knowledge or consent. Your staff need to be retrained and Your service managers should be fired. Refusing to provide a name as an agent for a public company with a public mandate is obstruction of Justice - Your agents do not have the right to privacy when they are Trusted with sensitive, personal, private information - especially when they are so demonstrably negligent and untrustworthy with that information.
