## NOTICE OF CIVIL AND CRIMINAL LIABILITY FOR HARASSMENT AND DISCRIMINATION

Dear Sarah Lorenz,

You AND Your maintenance team have been advised on numerous occasions that the RTA REQUIRES You to provide tenants with 24 hour Notice of entry and a reasonable window of entry, and KANEESHA is the One issuing the Notices for entry - NOT the maintenance department!!! If Kaneesha is NOT responsible for ensuring tenants receive proper legal Notice of Entry, then do not USE Kaneesha as the individual responsible for issuing the Notices, ensure that YOU or Your lawless maintenance team send the Notice.

Any Notice for violating the terms of My lease INCLUDES violating the RTA and YOU and YOUR maintenance team are completely ignorant of Your duties and ROUTINELY fail to provide legal and lawful Notice of entry as You are REQUIRED to do according to the RTA (according to LAW). I know You are complicit with the LTB, but You HAVE been discriminating against Me in particular with extreme prejudice and I am sick and tired of it!!!

This email Will be used as evidence against You if You attempt to 'escalate' anything!!! You are a negligent criminal with no respect for the Residential Tenancies Act or the rights of Your tenants according to Canada's constitution.

I Will respond to any One who does not provide proper legal notice of entry that they are not legal or lawful notices of entry until You learn how to properly serve a Notice of entry. I will not be intimidated by Your threats and Will NOT be told that I am not

allowed to communicate with the 'communications' manager for Multifaith Housing Initiative OR You concede that You are discriminating against Me with extreme prejudice and can provide Me with an abatement of rent for My entire tenancy and I Will be happy to move on to greener pastures and rent from a landlord that respects My rights of those of their tenants.

Take Your contemptuous reply and attitude elsewhere, nothing I said was inappropriate for a 'communications' manager. She should be able to handle basic communications and should be including Me on any notices that are relevant to any other tenants or You are discriminating against Me with extreme prejudice by default (which You are and have been doing for My entire tenancy!).

I have advised You that I require receipts for rent *every month*. That request has not been revoked or changed and I am still waiting to see a SINGLE receipt for rent - I Wish to receive one every month and I have the RIGHT to demand that You provide that or You are in violation of the RTA!!!

Have a nice day unless You Wish to be liable to Me in Your personal, private capacity. I did not insult any One or write anything inappropriate, I simply demanded to be treated with the same courtesy and respect any other tenant would be as King for. That is NOT unreasonable and Your email constitutes harassment and discrimination.

An 'appropriate reply' to My email (if You felt it was inappropriate - which is subjective OPINION and not a fact), Kaneesha could respond to say 'please contact such and such email address, that is not My department'. I do not consider a 'buzz code' to be a maintenance issue as Faisa was in Kaneesha's role previously and was responsible for keys and assigning a buzz code. If You have changed duties assigned to various staff members, that is not for Me to know 'psychically' - I am not clairvoyant.

It is YOU that is belligerent and discourteous - a bully!!! You do not EVER address the substance of the Issue, continue to violate the RTA with respect to Notices and You have received several notices which proves extreme negligence with respect to Your duties and responsibilities as a landlord OR criminal intent and passive aggressive, abusive behaviour insulting tenants who are making demands for You to Honour their rights and Your duties as a landlord to act in compliance with the RTA.

I am tired of Your continuous gaslighting. What is the explanation for the last unlawful notice of entry served hours after the maintenance People were finished their work? What is Your excuse for that today, and why was Kaneesha sending the Notice if maintenance has nothing to do with her? Is that a reasonable question?

I look forward to hearing from You if You can reply without passive aggressive, abusive gaslighting.
