In a recent decision You made regarding a tenant's claim, You unlawfully removed the tenant's choice of counsel based upon fraudulent allegations made against him in relation of his online publication.

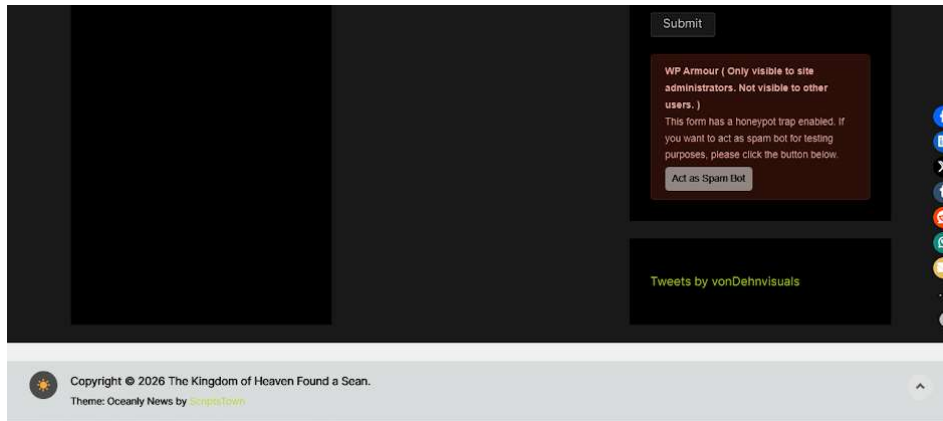

Another example of the Board granting special favours to members of their criminal society of liars posing as lawyers in violation of the rules, allowing the liar posing as a lawyer to proceed with his arguments by Way of ambush litigation. That is not due process or a fair and impartial hearing.

10. The email that was sent to me contained two separate links. Link #1 is an article regarding the Landlord's Legal Representative and Link #2 is in article regarding an Adjudicator, James Campbell which also includes a recording of a live hearing with Adjudicator Campbell. He also provided a copy an LTB order. LTB-T-024798-23, where King Sean, House von Dehn had his application dismissed for inappropriate conduct and an abuse of process.

The application was not dismissed for inappropriate conduct and abuse of process, the claim was dismissed because James the Colluding Campbell was more interested in colluding with the criminal landlord's theft of public money and breach of the tenant's privacy and Trust to steal his utility benefits than he was in the administration of justice.

That is fraud and misrepresentation of the facts. It is not 'hearsay' that the landlord was stealing utility benefits, that is part of the evidence before the Tribunal related to the claim James Campbell dismissed as having no cause of action, suggesting it was a 'defamation suit' rather than a rights violation hearing for being bullied by the landlord and their community volunteers for his vaccination status and rights advocacy.

But that's still not as egregious as the crimes of Trish the Colluding Carson who decided to omit the most relevant context of the information she cuts, pastes, and edits to comply with her fraudulent narrative. “James W Campbell, Mr. Chair of the Landlord and Tenant Board is hereby referred to as “Mr. Stool” for being a colossal piece of shit and colluding with Landlords to dismiss a claim where it was reported by way of evidence produced by the “Landlord’s liar”, Micheal the Tyrannical Thiele.”

Actual quote - "James W. FINAL NOTICE OF CRIMINAL LIABILITY: FRAUD, DEFAMATION AND COPYRIGHT VIOLATION

Just a courtesy Notice of reminder that if I do not hear from You before 5:00 TODAY, You are tacitly conceding to all criminal charges against You without protest.

If You Wish to apologize for Your fraud, trespass and breach of Trust, You can Write Me a letter of apology explaining why You misrepresented My blog post by omitting the relative context which reported that James William Campbell was called 'Mr. Stool' failing to report that the not for profit landlord MHI was found to be *stealing utility benefits from the tenant*.

That also constitutes collusion in fraud and theft of public money with James William Campbell and his determination to use this Board as a cloak for the landlord's fraud, breach of Trust and theft of public money (*criminal*, not civil offenses which should *immediately* be reported to police by any Honourable member of the Board - let Me know if You hire any). Frankly, I also believe any *Honourable* member of the *Board* Acting in Good faith would report the Matter to City of Ottawa fraud and waste management - too bad I haven't had the opportunity to know any.

It is an unusual coincidence that You would engage in the same fraud when the subject Matter relates to the same criminal not for profit landlord (Multifaith Housing Initiative) exploiting the rights of tenants and refusing to complete routine maintenance for more than three years.
