Good morning,

This email is in response to your access to information request received by the Privacy Office on January 30, 2026. You requested records pertaining to the following:

- 1) Any recordings that pertain to the request for a cheque for the credit on the account for 'SEAN VON DEHN' and any notes on the file for every call you made with respect to requisitions made about your account for the time period from October 1st through to your last call to our office. **Please note we have not provided anything that is solely operational as it is not subject to disclosure.**
- 2) A copy of any consent Ottawa Hydro agents allege to have on file that gave our agents permission to discuss details of your account with third party intervenors without your prior knowledge or consent. **Hydro Ottawa does not have a copy of this consent. You provided this consent directly to Ontario Works. As this record is not within our custody or control, we cannot provide it.**
- 3) The last name of 'Renee' at Ontario Works. **The last name of this individual is not relevant to your access to information request and for that reason we have not included it.**
- 4) A copy of the telephone communication as well as any other communications Ottawa Hydro had with third parties with or without your presumed consent. **I would note that all recordings should be downloaded.**

I am pleased to provide access to the documents relevant to your request, which are disclosed under the authority of the *Access to Information Act*. Please see the link to your documents below. You will have access to this confidential directory until March 2, 2026. Please use this time to download the materials. Access will be removed after March 2, 2026.

Good morning,

I hope 'due course' does not mean March 2nd. I requested the information for disclosure of all communications with agents of Your office from the service agents of Your office before getting fed up waiting for a reply and following up by email. Your 'thirty days' to comply with My request begins on the day the request was first made.

You have breached My privacy and said You had a consent form on file that allows You to do so. I require a copy of that consent form ASAP. OR, I require for You to concede to Me that Your agents have been lying, have NEVER had My consent to communicate about My private information or details concerning My hydro bill with third parties without My express knowledge and consent.

Also (and as Your agents were advised) when I request the last name of an agent for the purpose of litigation and an agent *refuses* to Give Me that name or the first and last name of their immediate supervisor and or manager, that is obstruction, aggravated harassment, collusion and conspiracy. It is to Act in 'bad faith'. Only criminals with something to hide Wish to conceal their identity.

It is not reasonable or correct for any One at Ottawa Hydro to not know that agents Trusted with sensitive information are required by Law to Give their first and last name for the purpose of accountability and liability *upon request*. When ALL agents and their supervisors are withholding that information, that is more than negligence or malfeasance, it is obstruction of justice, collusion and *aggravated criminal harm*.

How long before I should expect to receive copies of those telephone records and the Notice of consent to breach My privacy You allege to have on record? You've been using it with such impunity, I have Good reason to presume You *must* Keep it handy.

Good afternoon, anonymous agent of the Ottawa Hydro Privacy office,

I Wish You respected and protected My privacy as much as You protect the identity of Your own agents Trusted with My personal information. Thank You also for confirming receipt of the Final Notice of Civil and Criminal Liability that was served upon the privacy office and Your legal department earlier today.

The particular recordings in question are any that pertain to the request for a check for the credit on the account for 'SEAN VON DEHN'. Service agents allege to have 'notes on the file' for every call I have made with respect to requisitions made about My account.

The time period includes any calls made to Ottawa Hydro from October 1st through to My last call to Your office.

I also require a copy of any consent Ottawa Hydro agents allege to have on file that Gives Your agents permission to discuss details of My account with third party intervenors without My prior knowledge or consent.

I require the last name of 'Renee' at Ontario Works who allegedly advised Ottawa Hydro not to send the payment, and I require a copy of that telephone communication as well as any other communications Ottawa

Hydro had with third parties with or without My presumed consent.

Otherwise, I require a copy of all telephone communications with Your agents from the first time the request for the credit on the account was made (which You should have an accurate record of and I believe took place sometime in October. I wasn't aware Your agents lied so compulsively and continuously, so I hadn't had the foresight to record the conversations myself. Many of the more recent calls I have My own records but wish to compare them with Yours to ensure that records are not being altered or spoliated).

Is that a clear enough time period for You? Please confirm receipt as soon as possible, I look forward to hearing from You, anonymous privacy person.
