Okay, you don't have the court number though..

How many digits is that? It either starts with like 25-114..

How about you tell me the name of the matter? Okay, the last name is spelled V-O-N, hyphen D-E-H-N..

Oh, it's for you..

It's not for me..

That's the whole point..

If it was me, it wouldn't have a hyphen in the last name, would it? Okay, the prosecutor's engaged in fraud..

I need to bring a Form 1 application to address the fraud..

and I've been writing the trial coordinator's office for a long time and I've been ghosted..

So from my understanding, Steven Lictie, the prosecutor has 15 days to respond to my Form One application..

Okay, I'd like to schedule a hearing for that matter..

Do you have a lawyer or is it just yourself? What would I need a lawyer for? Will this line is only for lawyers? Yeah, no, I- Everything else needs to be set on the record if you're self-represented..

I'm not self-represented, because- Then who is representing you? I'm not being charged..

Okay, you've got some artificial person fake name on the registry..

That's a fact..

You've just acknowledged that the name of this file is VON-DEHN..

and then you responded by saying, oh, so this is for you..

Absolutely not..

This is not for me..

The individual named on the information is not me..

That's the issue..

How did you get these coordinates? They were given to me by the trial coordinator's office..

Okay..

Do you know when? Cause I thought you just said that the trial coordination office was toasting..

They were..

This is the only thing that I received from them..

So I'm trying to set up a motion..

They told me that the Trial Coordinator's Office is open on these days..

I was told to communicate with the Trial Coordinator's Office to set up a form one hearing..

Yes..

So let's do that today..

That needs to be done on the record because you don't have a lawyer..

Well this is a court of record..

This is a court of record..

Well, well, okay..

We need to I've been asking for a motion forever..

And the court has been ghosting me..

That is not acceptable..

I need them to respond to my form one application..

Do you want me to do you have an email address that I can forward my requests to you? And we can discuss this maybe tomorrow? No, I found your email, I guess..

Well, well, let's let's let's verify that to make sure because what what email? What email address was it received by? Because there's a number of email addresses..

Okay, go ahead..

Okay, so that's not the most recent that that has been sent..

There have been a number since then..

But you'll notice that no one's responded to that..

You will notice that..

Well, can you confirm for me that no one has responded to that? Well, I'm not sure because you're telling me that there's a newer email..

Well, okay, but wait a minute..

If you responded to that one and I had been given a file or a motion for my Form 1 application, if that had been done, then why would I even require another email address? Why is no one responding to that one? So the other email address that I was given was the address for the Trial Coordinator's Office because that email was ghosting me..

I see..

Okay..

I have an email from January 3rd..

Okay..

I'm going to look back..

I think there's even been one more recent than that..

But I will take a look..

Yeah..

It looks like January 9th is the last one I see..

I'm going to let you know who this one out to exactly..

Let me see the first thread..

The first thread for this form was sent to, I'll read you all the email addresses that it went to..

It went to Ottawa SCJ courts or [Ottawa.SCJ.courts.ontario.ca](mailto:Ottawa.SCJ.courts.ontario.ca)..

Crown Ottawa, virtual Crown Ottawa at [Ontario.ca](mailto:Ontario.ca)..

Steven.Lichty at [ppsc-sppc.gc.ca](mailto:ppsc-sppc.gc.ca)..

And it went out saying I received a phone call from the criminal desk at the Ottawa Courthouse advising me to send my Form 1 application for rights violations and to address the registry fraud to [Ottawa.criminalatontario.ca](mailto:Ottawa.criminalatontario.ca)..

So that one was also included..

Please also take notice that I have included virtual crown Ottawa at [Ontario.ca](mailto:Ontario.ca) on this notice because their office has been ghosting my email requisitions for disclosure and to request a motion to address the registry fraud, the violation of my rights and malicious prosecution in violation of countless charter rights..

I'd like to request for the motion to be heard virtually as appearing in person has already caused the accused an egregious amount of undue economic harm and duress in violation of his rights..

I look forward to confirmation of the filing of this application as soon as possible..

An example of the incompetent courts of jurisdiction the accused has thus far been subject to in violation of his rights to a court of competent jurisdiction..

And I include a link to the last hearing before Julie Bourgeois, who said that she is not Court of Competent Jurisdiction cannot inherit the jurisdiction necessary to provide relief and remedy for rights violations and that I would need to set up a new hearing for the Form 1 application to address those rights violations..

Okay..

I have found the Form 1 that you filed..

So again, I can't set it on this way because it needs to be done on the record..

So I will respond to your email today, providing you with the date, all right? OK..

And what is your name, please? My name is Sarah..

OK..

So that is one matter..

This is only one of about five different matters that the courts are ghosting me on..

So can we set up a motion to address all of those? I need to settle a number of matters before the court..

Can you advise me if there are all, like I can only deal with the Ontario Court of Justice..

If you have anything with SCJ, like Superior Court or Family or SILO, we cannot deal with that..

Those are separate courts..

OK..

Well, again, this motion that I want to bring, that you're saying that you're going to respond to, needs to be a Superior Court of Justice..

And Ontario Court of Justice is not a court of competent jurisdiction..

OK..

You can read that on the Ministry of the Attorney General and Department of Justice website if you want..

It says that the only courts in Canada that are of competent jurisdiction are the superior courts of the provinces and territories..

Okay..

Well, given that information, I will respond to your email today..

I'll provide you with a date and then again, if you decide that that does not work, we can look at..

If I decide what doesn't work, like you're gonna set up a date before the provincial court again?

Yes..

Because that is what I can control..

So what I would like to know is who can I talk to at the court that's not going to ghost me and provide me with what I'm asking for? I'm not asking you for a provincial court..

I just told you that they don't have sufficient jurisdiction to hear this matter..

Okay..

Well, you're only talking to a provincial court right now and it looks like the the superior court was included in the email that you sent..

And that you read out..

Okay..

So I need someone from that, from that office to respond to me..

Failing to do so is obstruction of justice..

So can you have someone? I'm not going to pass the message along, sir, but I can't do anything scheduling-wise for you..

Uh, well, who is responsible? I'm not going to talk to them..

I don't interact with them..

Well, I've spoken to, I'll tell you who I have spoken to..

I've spoken to William Coyne..

And William Coyne is the one that gave me this email address..

Because he's trying to help me..

He says that it has nothing to do with him..

that he doesn't know why any of the clerks working for his court are not responding to me and confirming receipt of my requests..

That is literally obstruction of justice and it's being done to me by clerks of your court and when I say your court I am talking about the provincial court ma'am..

I'm going to respond to your email but I can't schedule anything if you are looking for a superior court..

And you're going to respond to the email that I read to you today on this call? Yes, no, I'll respond to you, yes, to the January 9th email..

Okay, that's not the one that I quoted here, I don't think..

Wasn't it December 11th that I said that? Okay, so the last email appears to have been sent on January 9th, I think..

So you want me to respond to that one? Well, that's the same one, that's in the same thread..

Is that correct? I believe so one second..

Yeah..

Yes, it looks like there's a December date in the thread..

Okay, and your name again, sorry? It's Sarah..

Sarah, and your last name, Sarah? It's Hodgson..

Hodgson? Thank you very much..

I appreciate that and I will look forward to getting your email..

No problem..
