Dear Mr. Potechin and Ms. Burton,

On May 6th, at 10:55 AM, you were served with a formal notice regarding the fraudulent handling of my father's estate and your joint and several liability. You were given a clear 24-hour deadline to report the fraudulent disbursement of funds to the appropriate authorities.

As of this moment, the 24-hour deadline has expired without any response or action from you.

Your silence is not neutral. In law, it is an admission known as ***Nihil Dicit***—"he says nothing." By failing to refute the allegations of fraud and failing to report the crime, you have, by your inaction, confirmed every fact stated in my notice. You have defaulted.

This is no longer a matter of dispute. The fraudulent nature of the Certificate of Appointment of Estate Trustee is a matter of public record, easily verifiable by a single call to the court. Your failure to verify this document before disbursing over half a million dollars constitutes gross negligence at best, and complicity in fraud at worst. Therefore, consider this your final and only notice:
