Notice of Civil and Criminal Liability: Criminal Breach of Trust

Dear Cathy Curry,

I requested for the credit balance on a Hydro Ottawa account to be paid out to Me after learning that a subsidy I was entitled to receive had been going into the hands of not for profit slumlord, MHI (Multifaith Housing Initiative) instead. When I learned that MHI and Home for Good had breached the consent forms provided to them so that they could steal My subsidy, I requested to have all the money paid to Hydro from the basic needs portion of Ontario Works be repaid to Me.

Of course, Lili the Malevolent Moron Mukalay at Ontario Works refuses to provide receipts to show exactly how much the Beneficiary has paid from basic needs in fraud over the last six years while he was entitled to receive a benefit that was going to the slumlord MHI instead.

Somehow, Chuck Ng of the legal aid clinic in Ottawa determined that if the credit balance of \$380. that had accumulated on the Hydro Ottawa account for overpayments were repaid to the Beneficiary, he would be 'made whole' for the theft of over \$3025 stolen from him over six years. He advised the Beneficiary to request for the credit balance on the account.

We're not sure where Chuck studied math, but \$3025 - \$380 leaves a balance of \$2645 still owing to the Beneficiary. MHI admit to stealing \$1018 which was repaid by OW, leaving a balance of \$2007 still owing. Obviously, after learning about all of the fraud and collusion by Ontario Works, Home for Good and MHI using consent forms to collude and steal subsidies the Beneficiary was entitled to, consent to communicate with those agencies without his express Writ of consent was revoked.

The Beneficiary requested for the credit balance on the Hydro Ottawa account to be paid out to him. Hydro Ottawa said that the City of Ottawa advised not to release the payment and to 'leave the credit balance on the account'.

I was furious to learn that Hydro Ottawa was communicating with Ontario Works and City of Ottawa employees without My knowledge and consent and placed them on Notice of Liability for breach of Trust and requested for a copy of all telephone records related to the request.

Wouldn't You know that the disclosure revealed that 'Cathy Curry' instructed Hydro Ottawa to leave the credit balance on the account and to tell the Beneficiary that OW

refused to release the payment to him. They lied and said the direction was coming from 'Renee' (who conveniently has no last name). The disclosure revealed it was not 'Renee', it was Cathy the Colluding Curry.

Can I ask why You are discussing My Hydro Ottawa account without My consent and why You instructed them not to release the credit balance on the account? Once again, I have a copy a phone call where the manager advises a Hydro Ottawa agent that the credit balance cannot be released as per instructions on the account by 'Cathy Curry'.

Why are You discussing My Hydro Ottawa credit balance with anyone? You were certainly correct about the City of Ottawa's 'kickback scheme' being 'just the tip of the iceberg', right? As it turns out, You have been instrumental in helping the City of Ottawa funnel utility benefits into the hands of not for profit landlord, MHI?

Would You like a copy of the Recording? What do You have to say for Your Self? Can I have an apology, please? That wasn't very nice, Cathy and I have now received the money - but only after demanding a copy of the phone calls to determine who was interfering with My business. Last night I discovered the 'meddler' was You.

You are liable to Me for breach of Trust with malicious, criminal intent to steal public money and obstruct My access to justice and remedy for Your previous theft of public money. The city of Ottawa owns Hydro Ottawa and is therefore liable for their criminal wrongdoings as well.

When One or more individuals are conspiring together, You are all jointly and severally liable. How do You Wish to correct this criminal wrongdoing done to Me?

Quite the little 'kickback scheme' You have orchestrated for slumlord's posing as philanthropist landlords.

Good morning, Wendy,

You are liable for making sure that public servants serve the public and corporations providing essential services Honour their Role and respect the privacy of clients and the MFIPPA. Cathy Curry has been found to be colluding with Hydro Ottawa discussing details of client accounts without the knowledge and consent of the respective Hydro Ottawa client.

This is an egregious breach of Trust on the part of Cathy the Colluding Curry and constitutes a violation of the MFIPPA. The disclosure requested from Hydro Ottawa was also redacted to hide the names of city of Ottawa employees and Hydro Ottawa staff that were found to be communicating about the account in violation of the MFIPPA.

I believe these communications are instrumental in the City of Ottawa's 'kickback scheme' and that they use the information obtained to funnel subsidy money into the hands of not for profit landlord, MHI.
