The Image removed from vondehnvisuals.com, "<https://www.vondehnvisuals.com/wp-content/uploads/2026/06/Linda-the-Sadistic-Sumbo.png>" is NOT copyright protected material, it is a Creative Product-Sean of a publicly sourced Image of Linda Sumbo, a public figure who has been celebrated for her achievements in the black community. I have Created a digital por Trait to accentuate the Spiritual nature of her Character.

Linda Sumbo is a graduate of Carleton University and is actively working to restore the public Image of a criminal not for profit slumlord in the City of Ottawa without reporting the theft and money laundering scheme to authorities.

The request to take down this photo is because Linda Sumbo does not like how I'm portraying her Character but she is colluding with a criminal landlord and helping them to embezzle subsidies intended for marginalized minorities into the slumlord's pocket instead.

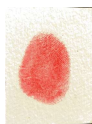
