Statement of Claim

To the Defendants

:

A Lawful proceeding has been commenced against You by the Trustee and Executor of the Kingdom of Heaven Found a Sean. The claim made against you is set out in the following pages.

If You Wish to defend this proceeding, You or an Ontario lawyer Acting for You must prepare a Statement of Defence in Form 18A prescribed by the Rules of Civil

Procedure, serve it on the plaintiff's lawyer or, where the plaintiff does not have a lawyer, serve it on the plaintiff, and file it, with proof of service in this court office, WITHIN TWENTY DAYS after this statement of claim is served on You, if you are served in Ontario.

If You are served in another province or territory of Canada or in the United States of America, the period for serving and filing Your Statement of Defence is forty days. If You are served outside Canada and the United States of America, the period is sixty days.

Instead of serving and filing a statement of defence, You may serve and file a Notice of Intent to defend in Form 18B prescribed by the Rules of Civil Procedure. This will entitle You to ten more days within which to serve and file Your Statement of Defence.

IF YOU FAIL TO DEFEND THIS PROCEEDING, JUDGMENT MAY BE GIVEN AGAINST YOU IN YOUR ABSENCE AND WITHOUT FURTHER NOTICE TO YOU. IF YOU WISH TO DEFEND THIS PROCEEDING BUT ARE UNABLE TO PAY LEGAL FEES, LEGAL AID MAY BE AVAILABLE TO YOU BY CONTACTING A LOCAL LEGAL AID OFFICE.

IF YOU PAY THE PLAINTIFF'S CLAIM of \$10,000,000.00 (ten million dollars), and \$500 for costs associated with these proceedings within the time for serving and filing your statement of defence, You may move to have this proceeding dismissed by the court. If You believe the amount claimed for costs is excessive, You may pay the plaintiff's claim and \$400 for costs and have the costs assessed by the court.

TAKE NOTICE: THIS ACTION WILL AUTOMATICALLY BE DISMISSED if it has not been set down for trial or terminated by any means within five years after the action was commenced unless otherwise ordered by the court.

The Trustee hereby Claims that:

On June 14th, 2026, the legal team and administration office of Ottawa Carleton University were advised that one of their student graduates, Linda Sumbo and one their professors, Doctor Tessa Hebb, were responsible for threatening a tenant of Multifaith Housing Initiative who reported in an 'impartial survey' that the not for profit landlord were stealing tenant subsidies in collusion with City Councillor, Cathy Curry and using the Ottawa Police Service to threate and intimidate the informant. This is a gross violation of Carleton University's own policies requiring their institution to report fraud and protect whistleblowers (<https://carleton.ca/secretariat/wp-content/uploads/sites/158/2022/04/Whistleblowing-Financial-Fraud-Prevention-and-Reporting-Policy-2025.pdf>).

This is an egregious breach of Trust causing irrevocable harm to countless Entitled Beneficiaries and a disgrace to Canada's Educational Institutions.

Substantial evidence of the fraud has been documented by King Sean, House von Dehn on his domain, vondehnvisuals.com where he documents any Acts related to his fiduciary obligate-Sean to protect the inherent, Constitutional rights of Canada's People and to protect them from exploitive business practices.

The Trustee is as King for \$10,000,000.00 in damages for two unlawful arrests using 'fake' names to avoid alerting the Registry to the Trust Instrument House von Dehn has on Record with MOJAG, and the multiplicity of suits proceeding against his deceased father, Joachim Heinrich von Dehn in fraud.

This is a highly sophisticated criminal operation involving collusion between city councillor, Cathy Curry, Chief of Police, Habib A. Sayah, Chairperson for Multifaith Housing Initiative (MHI), Sahada Alolo, where they collude in secret to violate consent forms so they can determine how much Beneficiaries are paying in additional housing costs (such as utilities, phone, and rental insurance) which are covered by the subsidy but funneled into the coffers of MHI while the Beneficiaries continue to pay these costs from their basic needs, effectively starving tenants and depriving them of their basic subsistence.

The ten million dollars the Trustee is as King for is in restitution for damages for six years of extreme discrimination and retaliation in the community for his advocacy work and journalism, trying to bring this very sophisticated criminal organization to light.

The Trustee is as King for one million dollars for the personal damages and suffering done to the Beneficiary, Sean Stephen von Dehn, and for the remainder nine million to be placed into a Trust account for the remaining tenants who have also suffered egregiously by the theft of their subsidies.

The Trustee is also as King for criminal charges to be laid where appropriate, and for a full forensic accounting audit to be demanded of MHI so We can determine how much money they have stolen from Canada's People.

Find proof of service attached. This Notice has been served upon the Respondents/Defendants in accordance with the Rules of Civil Procedure and filed with the Ottawa Superior Court of Justice by Way of email.

King Sean of House von Dehn has Sworn an Oath to protect the inherent, Constitutional rights of Canada's People. Criminal breach of trust:

336 Every one who, being a trustee of anything for the use or benefit, whether in whole or in part, of another person, or for a public or charitable purpose, converts, with intent to defraud and in contravention of his trust, that thing or any part of it to a use that is not authorized by the trust is guilty of an indictable offence and liable to imprisonment for a term not exceeding fourteen years.

Breach of trust by public officer

122 Every official who, in connection with the duties of their office, commits fraud or a breach of trust, whether or not the fraud or breach of trust would be an offence if it were committed in relation to a private person, is guilty of

(a) an indictable offence and liable to imprisonment for a term of not more than five years; or

(b) an offence punishable on summary conviction.

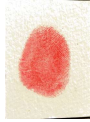
