☸ FORMAL LEGAL NOTICE ☸

Dear Dr. Hebb,

I wish to clarify the Purpose of My previous correspondence and express what I am actually hoping for in this situation.

The opportunity before you:

I am not Writing to threaten You, but to appeal to Your professional expertise and moral compass. As a doctor of social and political sciences with expertise in finance, You possess precisely the credentials needed to recognize what is happening here!

What should be obvious to you:

The mathematical impossibility of a "not for profit" claiming poverty while spending \$15,000-\$25,000 on public relations instead of essential maintenance.

The ethical contradiction of conducting "tenant satisfaction" surveys while tenants suffer without basic services and orchestrated theft of their subsidies.

The legal implications of participating in 'kickback schemes' that systematically divert public subsidies from vulnerable populations.

Why your expertise matters:

What might not be clear exploitation to others should be glaringly obvious to someone with Your training. No Divisional Court Will believe it is 'reasonable or correct' to accept

that a PhD in social and political sciences with finance expertise could fail to recognize these patterns of exploitation.

What I am actually hoping for:

I am filled out one of your surveys with complete documentation of the situation. My sincere hope is that when You review this evidence, You Will:

Recognize the severity of the exploitation

Abandon your client if they refuse to address these issues immediately (repay all stolen subsidies, provide receipts to tenants).

Report these matters to appropriate authorities.

Use your position to advocate for those who cannot advocate for themselves.

Demonstrate that You are capable of teaching ethics by Your moral example, rather than documented theories on paper with no practical application.

The alternative:

If You choose to remain silent, You are not just failing to respond to My notice - You are failing to uphold the professional and ethical standards that Your credentials represent. Your silence would be interpreted as acknowledgment that even those with the highest education and expertise Will participate in the exploitation of vulnerable populations when financial incentives are involved.

The choice before You:

You have the opportunity to be the person who says "This is wrong and I'm going to do something about it" - which should be the normal response when confronted with evidence of exploitation, but has become disappointingly rare.

To be honest, Dr. Tess, when I received that email from Linda Sumbo, I was exceedingly hopeful - I thought the 'Community Town Hall' and its publication were finally attracting the right kind of attention. I saw the Carleton University Logo and I thought to My Self, 'Wow, this is Real, they are ACTUALLY going to do something!', and I filled out the survey with optimism and enthusiasm. I sent off the survey, thanked Linda with not an ounce of bad faith in My body.

Then, I re-read the email to find out who precisely is analyzing the data received, and discovered 'Hebb, Knights and Associates' and did some background checking and discovered You represent a Public Relations firm and charge \$15-25k per contract, typically. Three years tenants have waited for the MAU to be repaired, last LTB hearing they said they can't afford to repair the unit until at least the fall. They said they couldn't afford a security camera so tenants can feel safe about who they are buzzing into the

building, but they spent thousands on private cameras to surveille the tenants unlawfully, in violation of MFIPPA and the RTA - as is refusing to provide receipts to over 400 tenants.

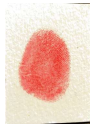
