Dear Kelly the Criminal Kritsch,

Attached, You Will find My correspondences to both Your Self and Ontario Works, Lili Mukalay and Mathieu Regimbald after discussing with You on the phone that THERE HAS BEEN NO CHANGE to My income, I still qualify for the subsidy, and the subsidy should continue with an extra \$5.00 allocated to utilities from the Housing Portion of Benefits.

This means OW Will pay \$20/month directly to Ottawa Hydro. You don't need My Hydro Account Inform a Sean because You are already paying directly from Housing portion of Benefits, You simply need to change the amount to \$20 and add the remainder \$40 to the basic needs portion.

As I clearly expressed in the attached emails, You DO NOT have My consent to discuss ANYTHING with any One without My direct oversight because You LIED TO THE BENEFICIARY ABOUT HIS ENTITLEMENTS FOR FIVE YEARS (AT LEAST) and Gave My Entitlements to the slumlord, MHI instead!!! That is part of Ottawa's 'Kickback Scheme'.

I Gave Mathieu Regimbald EXPLICIT instruct-Sean's to continue the subsidy and to only change the amount paid to Hydro directly by \$5. (five dollars).

Furthermore, You also LIED TO ME ABOUT APARTMENT INSURANCE, incorrectly advising that those costs Will need to be paid from My basic needs UNLAWFULLY, depriving Me of essential basic needs necessary to maintain My basic health and well being. That is FRAUD with INTENT to cause harm!!!

This Matter before the SBT concerns the REPAYMENT of these EXACT Entitlements. Lili Mukalay is guilty of obstruction of Justice because she is REFUSING to provide copies of the Trust Instrument, Trust Declare a Sean, Letter of Attorney, and Mandamus for Health Care, each of which were Signed by Commissions of the Ministry of Children, Community and Social Services, Orsolya Vancsody. My Signed copy of each of those documents Showing they were received, Signed and Stamped with the Ontario Works Seal, Promising to Honour.

I require the last six years of basic needs receipts to Show how much the Beneficiary, Sean von Dehn has paid from his basic needs in utilities so that I can be made whole for Your previous theft. Failing to produce those documents is obstruction of Justice and FRAUD by Way of omission, denying the Beneficiary the evidence necessary to prove his Claim!

Once again THIS VERY MATTER before the SBT is for REPAYMENT OF STOLEN UTILITY ENTITLEMENTS.

I am ENTITLED to compensation for the five years I have NOT had rental insurance because You lied to Me about the Benefit being covered by the Entitlement. I am also Entitled to receive costs for phone because the Ontario Works Act considers phone a 'housing expense' if One is required to let visitors into the building.

And You Wish to have My consent to 'communicate' with Ontario Works to verify these facts while You plead ignorance to the three Way thread involving all interested parties attached to this email? That was done for the purpose of liability and to ensure no One claims that the subsidy was unlawfully revoked due to 'My negligence' and 'refusing to fill out the forms'.

When I first received the form (which I presume was May 11th or thereabouts), You confirmed by phone that the subsidy has been APPROVED and that 'I only need to advise Ontario Works of the changes We discussed on the phone, and I advised that I Will start a three Way thread including Lili Mukalay and Your Self so that there can be no confusion. That email remains unanswered which is EVIDENCE of criminal misfeasance regarding an Entitled subsidy if You are not Willfully attempting to plead ignorance.

This email is HARASSMENT and evidence of GASLIGHTING under threat of revocation of subsidy. I am NEVER Giving blanket consent to any organization that has proved to use that consent to exploit the Beneficiary and lie to him about his Entitlements.

Make sure the subsidy is restored and the amount paid to hydro is increased by \$5. Find out what company the Landlord likes to use for apartment insurance, set it up for the unit, and pay it directly as that is Your obligation that I am ENTITLED to receive. You Will also provide Me with \$30 month for sixty months or \$1800 (eighteen hundred dollars) which is equal the Entitlement You wrongfully stole from Me (lying to Me about an Entitlement is theft of property).

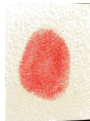
Does that answer all Your Questions, Kelly? This email exchange Will be added as evidence to the OPS reporting file 26-204142.
