Dear Robert Brown,

I am in receipt of your Order dated July 29, 2026. Please be advised that this Order is being entered into the Record as a prime example of malicious, intentional procedural unfairness and abuse of process for the purposes of criminal complaint #26-204142 - MHI 'Kickback Scheme', using the LTB and SBT as a laundering facilities for a slumlord demonstrating gross contempt for the RTA, Ottawa's Property Standards, and 'gaslighting' the Jurisdiction of the Trust for its intended Beneficiaries.

Your Order is legally void and founded on a constructive fraud. By pleading ignorance of the "The Kingdom of Heaven Found a Sean" Trust, You have breached Your equitable duty and misrepresented the Jurisdiction of this Tribunal. A Trustee acting on behalf of a Beneficiary cannot be penalized for the Lawful Actions of the Trust, and a Beneficiary is shielded from such penalties by the very existence of the Trust. The Tribunal has no standing to fine either.

Furthermore, the appeal was made by the Trust, not the Beneficiary. Your Order is a direct and unlawful attack on the Trust's inherent jurisdiction to Act in the best interest of its Beneficiary.

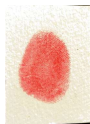
