Subject: RE: Response to Inquiry of Identification Documentation / Formal Notice of Compliance, Recorded Evidence, and Active Warrants

Good morning Sandi,

I am writing in direct response to your email of July 22, 2026. Our June 25th call was in fact lawfully recorded and the forensic file from our call was sent to the investigators. There is no need for you to gaslight me:

1. Proof of Identification and Administrative Admission

Sarah.Dalton@ottawa.ca's confirmation that she successfully received my identification and submitted my application to The Registry on July 21, 2026, definitively proves that **no further identification data was ever required from me personally**, since the time of our lawfully recorded call June 25th and that the documents were already accessible within municipal networks

(Ontario Works) all along. This confirms that the weeks of illegal administrative obstruction were entirely avoidable.

2. The June 25th Recorded Conversation and Police Forensic File

- **The Recorded Call:** Our telephone conversation on **June 25, 2026**, was lawfully recorded. In that call, you explicitly walked through how the ID situation could and should have been resolved immediately, noting your background working at Ontario Works, yet you failed to comply.
- **Police and Forensic Integration:** That complete recording, transcript, and timeline have been formally submitted and logged as part of the active Ottawa Police Service and RCMP forensic files.

3. Bad Faith Clawbacks, Inaction, and Systemic Harm

- **Illegal Benefit Clawbacks:** While my authorized navigator Keegan Prempeh (Pinecrest-Queensway Community Health Centre) and the Anchor Program faced radio silence and bureaucratic blockades, Erin Finch, Lindsay Myatt, and Sarah Dalton unconscionably clawed back my shelter and assistance benefits during an active Social Benefits Tribunal appeal.
- **State-Induced Displacement:** Following an illegal eviction and displacement orchestrated by City of Ottawa lawyer, Taffy Nahas, my household—including my autistic son—was forced into a hazardous shelter environment. I repeatedly informed Sarah.Dalton@ottawa.ca that my physical ID was inaccessible because of this unlawful lockout.

4. Active Emergency Orders and Warrants

As outlined in formal notices issued by Court-Appointed Trustee King Sean, failure to comply with active emergency remediation directives, the immediate return of unlawfully clawed-back monies, and the urgent release of emergency relocation funds to secure safe, permanent housing has triggered formal default proceedings, active police oversight, and outstanding arrest warrants for bad-faith public administration.

I expect my emergency relocation funds and housing placement to be executed immediately today.
