🏯 FORMAL LEGAL NOTICE 🏯

PREAMBLE:

Please be advised of the submission of evidence and the issuance of a binding Order related to file SBT-2512-08602. This correspondence serves as a formal response to the ongoing refusal of the City of Ottawa's Ontario Works (OW) program to Honour its statutory obligations, resulting in the unlawful revocation of a housing subsidy and a subsequent threat of eviction.

EVIDENTIARY RECORD:

The following exhibits are submitted as fact and form the basis for the Order herein:

Exhibit 1: Notice to Evict for Non-Payment of Rent. This document is a direct consequence of the OW agent's refusal to process the legally entitled subsidy.

Exhibit 2: Kelly Kritsch follows up with email as King if I Wish for the subsidy to be reinstated.

Exhibit 3: Email Exchange in Three-Way Conversation Thread. This exchange, which includes OW Agent Mathieu Regimbald, clearly documents the request for subsidy processing and Mr. Regimbald's deliberate refusal to respond with transparency, thereby causing the revocation and Act of bad Faith.

ORDER FOR REMEDY AND RESTITUTION:

Based on the irrefutable evidence submitted, the following directives are hereby ordered:

Immediate Restoration of Subsidy: The \$60/month utility benefit for hydro is to be immediately restored and processed as follows: \$20 paid directly to Ottawa Hydro, and \$40 added to the Beneficiary's basic needs portion.

Financial Restitution for Theft: Kelly Kritsch and the Home for Good program are hereby ordered to pay restitution in the amount of \$2,027. This represents the total value of the utility portion stolen from the Beneficiary over a six-year period (2020-2026) during which OW deliberately LIED about the existence of this Benefit, unlawfully compelling the Beneficiary to pay these additional housing costs from his basic needs under duress.

Production of Documents or Criminal Charge: Should the Ontario Works program, under the management of Lili Mukalay, Wish to dispute the calculated restitution amount of \$2,027, they are hereby ordered to produce the complete "basic needs" portion of the Beneficiary's income statements for the entire period from 2020 through 2026. Failing to do so is constructive obstruction with malicious intent to pervert the course of justice.

I provided a DISCLAIMER to the SBT to advise that the only reason I was including them on the renewal forms was to Show that no Matter how explicitly or openly the Beneficiary attempts to comply with the Renewal Form Directive, Ontario Works agents REFUSE to comply and Act in GOOD FAITH!!! The demonstrable ignorance and or incompetence is unacceptable and criminal misfeasance.

The only year subsidies that were not unlawfully revoked by Kelly Kritsch without any Notice to the Beneficiary so that he can receive eviction threats from the landlord they are conspiring to steal tenant subsidies from, was last year, 2025.

That was when the Beneficiary learned that utilities are covered and included in subsidy, as is apartment insurance which Orsolya Vancsody lied to the Beneficiary about in 2020, advising he must pay rental insurance from his basic needs, as well as utilities, economically starving the Beneficiary - all while they were funneling these Benefits into the landlord's pocket as part of the City of Ottawa's Kickback Scheme.

This Matter and all other Matters concerning Sean Stephen von Dehn are now evidence in the Kickback Scheme ongoing investigation and those found to be complicit Will be arrested and charged accordingly.

FINAL DIRECTIVE:

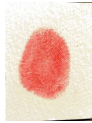
