Well, it was a busy day yesterday, ladies and gentlemen – lots to catch up on today! Thank King or Queen You for joining Me, it is always a tremendous Honour for My House to be Gifted with Your Presence.

The first notable deed of yesterday was placing Resolution Officer of the Social Benefits Tribunal, Madeleine Mbuyi on Notice of Criminal and Civil Liability for allowing the criminal conduct of the Administrator to continue until the date of the hearing. The moment any One in a position of authority discovers that One is being harmed by the criminal acts of another, they have a moral and ethical obligation to report the crime so that the Administrator can be arrested and removed from their position of office, preventing harm from becoming other Beneficiaries. However, violating the law and breaching contracts is so commonplace for Ontario Works agents that they are Given impunity to engage in egregious breaches of a Beneficiary's Trust by the Social Benefits Tribunal. Presumably, the only reason the Tribunal is not taking action is because they *must* believe I am *lying* despite the fact that I am presumed to be in Honour (telling the Truth) until My points are disputed by the Administrator. The Administrator has not even responded to the Appeal, except to say that they don't clearly understand the rights portion of the claim, it is too 'ambiguous'? Breach of contract is 'ambiguous'? Criminal trespass upon a Trust Instrument is 'ambiguous'? Is it ambiguous, or is Geoffrey the Bonehead Baker hoping We believe he is an idiot who doesn't know that every One is entitled to protection from criminals?

I'd let Geoffrey the Bonehead Baker respond, but he's too busy enabling the criminal trespasses of the public Trustee and their determination to gaslight a Trust

was to aggravate the harm done as much as possible before being compelled by the Tribunal to make it right. And of course, no consequences for the Administrator who PROVED to be guilty of breach of contract and unlawful revocation of benefits without Notice to the Beneficiary.

Because the Tribunal does not 'punish', fine or reprimand any One at Ontario Works regardless how egregious their breach of Trust is or how determined they are to aggravate the harm done to a Beneficiary, Ontario Works Will weaponize the Act against any One they Wish because the only individual harmed by their action is the Beneficiary who Will wait as long as Ontario Works can stall the Tribunal. When they are ordered by the Tribunal to pay a particular amount, advising them they had no legal right to do what they did, Caroline Forget Will argue with the decision and put whatever she feels is an appropriate amount into the Beneficiary's account without Notice to him so that he knows the funds are there and incorrect. I had to carbon copy the Vice Chair on another email thread with Caroline Forget where she argues with Me about what she is going to pay, despite the Tribunal's order. She is a belligerent, contemptuous clown.

Provision. 15. (1) Every individual is equal before and under the law and has the right to the equal protection and equal benefit of the law without discrimination and, in particular, without discrimination based on race, national or ethnic origin, colour, religion, sex, age or mental or physical disability.

And I would presume it also includes who is perpetrating the criminal Act, but not positive because the Social Benefits Tribunal appears to be hoping I Will believe that I am not entitled to equal protection of the Law from criminal Trustees violating My Trust Instrument with malicious intent because they are City of Ottawa employees who appear to be above the Law!

We're going to see if the Tribunal attempts to plead ignorance of the Trustee Act of Ontario, Canada's Criminal Code for malicious breach of a Trust Instrument, the Trust on file with Ontario Works, and the Trust Instrument on file with MOJAG (never Mind the other two contracts the Administrator Signed promising to Honour in Good faith). If they do, I Will be appealing the decision to a Divisional Court on the grounds that it is 'incorrect and unreasonable' for a Tribunal to allow criminal harm to continue for months, knowing it Will seriously aggravate the harm done to the Beneficiary. Any One too stupid to know that the Tribunal has a duty and obligation to arrest and remove the public Trustee, is not fit to be war King in a Trusted
