- Whereas, Court clerks, under Your supervision, have 'ghosted' My email requisitions to the Court regarding the management and administration of My Trust property, and
- Whereas, Your failure to respond constitutes a breach of Trust and a breach of the service standards of the Superior Court of Justice, and
- Whereas the criminal negligence of Your staff is ***the cause of additional aggravated harm becoming several Beneficiaries*** for which You, Kirsten the Belligerent Booth are now liable for in Your personal, private capacity as the Superior Court Clerk Supervisor directly responsible for the incompetence and criminal obstruction of Your staff in violation of statutory Orders and administrative procedures binding upon You and Your staff,

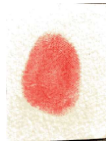
You are hereby served on the Guelph Superior Court of Record official email intake for which You and Your clerks are liable.
